Within the boundaries of McDonough County, Illinois are more than a hundred cemeteries and gravesites ranging in size from a single burial site to the expansize Oakwood Cemetery at Macomb. Within these cemeteries are the remains of an estimated 40,000 individuals who have died since the first settler arrived here over 150 years ago. Graves of countless others are scattered over the countryside of McDonough County; but, exact sites of many of these resting places are no longer known for various reasons. During the early days of this county, there were obviously no central burial grounds; thus, a pioneer family having the misfortune of losing one of it's members placed the deceased in a grave on a family homestead and erected a makeshift marker. A number of these family burial grounds later became public cemeteries, however, many of the grave sites soon became "lost". Crude wooden markers or a hand engraved stone soon succumbed to the elements and were never replaced; scores of families moved further west after staying in this area only a short time and the gravesites of their loved ones shortly became insignificant mounds of earth; a number of families passing through this vicinity suffered individual losses. A prime example of the latter is contained in a history of Bethel Township. In 1830, four children of an emigrant family died while enroute through McDonough County. They were buried near their places of death which occured about two miles southwest of Fandon. All traces of those graves have long been gone. During the summer of 1834, a widow lady died at her home in northern Tennessee Township. Her coffin of dressed walnut lumber was built by a local cabinet maker and she was buried in the timber near her home. Within a few years, no evidence remained to indicate the presence of her final resting place. A family who created an excellent farm from the prairies a few miles north of Macomb, maintained a fenced family burial site for several years. This cemetery contained the graves of about 12 former family members. During the early 1900's, the farm changed ownership. Shortly thereafter, the new owner removed all the stones, took down the fence, and this graveyard became part of a cornfield. These are only three of the countless incidents involving the total disappearance of burial sites. At this time, it is impossible to determine the locations of hundreds of individual's graves in this county.

Vandalism is responsible for the destruction of many grave stones. Countless markers have been partially or totally destroyed. Inscriptions have been obliterated by shotgun blasts, stones have been broken into dozens of pieces, and some markers have been entirely removed from the control of the control of

have been entirely removed from their original locations.

While weather-wear and vandalism accounts for most of the destruction of individual tombstones, neglect is directly responsible for the eventual deterioration of graveyards. Several local cemeteries have had no protective fencing for a number of years and the grounds have become grazing land for livestock. Groundhogs and other burrowing animals have undermined large portions of various cemeteries. Some areas are nearly invisible because of massive growths of weeds and brush. Stones have fallen, broken, and become completely covered with soil and debris.

The overall conditions of our county cemeteries is a pathetic case. While some grounds are well maintained, or at least partially kept-up by various families, many have been totally forgotten. This situation is appalling and should never have come about. Apparently, lack of time, expense, and most of all regard has brought about the present-day poor conditions of many of our rural cemeteries.

Genealogical notes accompanying the various cemetery listings were prepared from a wide variety of sources including:
Local area history books and atlases; newspaper files; county,
state, and federal archives; family histories. These notes were
collected at random from readily available sources and little,
or no attempts were made to search for material for more complete genealogies. These notes are presented only for the pur-

poses of identification and/or clarification.

Every attempt has been made to present complete and accurate information. Readers will find errors and omissions. Others will not agree with prortions of my findings; however, no information contained herein is based soley on assumption or guesswork. It must be remembered that this information has been prepared for use only as a tool for further research and that nothing must be taken as final and absolute.

The larger cemeteries contained in these volumes are accompanied by grave location charts. These charts in no way are intended to represent any professionally prepared plat or survey that may exist. Their preparation and presentation are

soley for general location purposes.

When copying inscriptions from grave markers, it is sometimes impossible to read some portions of the engraving. Names, dates, ages, etc. that were found to be unclear or totally missing are indicated by the use of question marks or dashes, i.e., SPICER, James T., infant son of ?J.B. & S.J.?; d. ----; age ----. The letters or numbers enclosed in parenthesis following the inscription, indicate general location as indicated on the accompanying chart.





# Me Denough County, Illinois




Areas covered by volumes I - XVII
"Cemeteries of McDonough County, Illinois"




## Chockley Cemetery

Location: Eldorado township, near the center of the  $SE_{\frac{1}{4}}$  of section 29;  $3\frac{1}{2}$  miles east and 2 miles south of Industry.

Remarks: One of the few county owned cemeteries remaining, this cemetery was deeded to McDonough County several years ago and remains under that ownership at this time. The grounds are well maintained on a regular basis. Most stones are standing upright and the majority are completely readable, although several are badly weather-worn. In the north-as follows: "In memory of Pres. Wilson, the unknown American soldier, and the Red Cross Nurse; erected by Albert L. Adams, not come home from the World War; erected by Albert L. (moved to Seward Co., Nebr.); Frank P.; James N.; Joseph F.; Mary P. (Mrs. Wm. Moore); Emma; Charles; and Annie (d. 1863).

Catherine (1832-1908), wife of Thos.; daughter of Robert and Nancy (Wilkinson) Comer, both natives of Ohio; Mr. and Mrs. Comer are buried in the Vance Cemetery.

Jacob (1832-1928); son of John and Massie Lawyer; md. Nancy E. Standard; they had 9 children: Arthur E., Alvin C., Dallas, Alva L., Shered, Franklin, George, Alma W., & Walter.

John (1801-1883), a native of Va.; lived and md. in Ohio to Massie Cooper; moved to this county in 1837; had 7 children; Thomas (b. 1826); William (b. 1829); Jacob (b. 1832); Jefferson (b. 1834); M. V. (b. 1836); and 2 others. John appears on the 1840 county tax list as # 490. He owned \$260.00 worth of horses, \$60.00 cattle, \$10.00 clocks and watches, \$80.00 wagons, and \$115.00 in other property; no real estate; taxes were \$2.63.

Sarah (1834-1865), wife of Michael Lawyer; she was a native of Ohio and md. Mr. Lawyer Sep 27, 1857; had 4 children: Emisiah, Isaac Luther, William K. and another. After the death of Sarah in 1865, Michael remarried, in 1868, to Minerva Downen, widow of David Downen. Michael Lawyer died in 1898 and was buried at Vance Cemetery.

Elvy (1890-1900) (Death notice, in part, from The Bardolph News, Nov 21, 1900): "Elva, the 10-year-old daughter of Mr. and Mrs. Dal Lawyer, of Eldorado Twp., was burned to death on Wednesday of last week. Mr. Lawyer set fire to a heap of corn cobs in his hog lot. Children from the schoolhouse nearby, among whom was the little victim, were playing about the fire during Mr. Lawyer's absence. Little Elva's clothes became ignited and before the flames could be quenched she received injuries which resulted in death."

### Springer Grave

The grave of Mordecai Springer, who died Nov 13, 1887, at age 76y 7m 24d, is located in a small, fenced area in the  $NW_{4}^{1}$  of section 26, Industry township. This is about 2 miles southoutheast of Industry, near the former site of the Crossroads School.

Mr. Springer's gravesite is just north of a former cemetery, known as Crossroads or Pleasant Grove Cemetery. Carter's Settlement was located in this general area and was one of the first settled areas in this county. Pioneer families came here in 1826-27, and in 1827, built a log fort for protection against local Indians. A cemetery was established here in the late 1820's, but all traces of it have long been gone. Early settlers in this vicinity included: Riggs Pennington, William Carter, in this vicinity included: Riggs Pennington, John Wilson, James Sela Tomberlin (a widow), Stephen Osborn, John Wilson, James Vance, Rev. John Logan, Isaac Fowler, and a Mr. Jenkins.

In 1871, M. Springer was indicated as the owner of 40A in this section; his home was located near the site of his grave. W. I. Springer owned 20A just to the west of Mr. Springer's property. The 1840 county tax list shows Lewis Springer as the owner of the entire  $NW^{\frac{1}{2}}$  (160A) of section 26. He also owned owner of the same section, and his residence was located on the  $SE^{\frac{1}{2}}$  of the same section, and his residence was located on the  $SE^{\frac{1}{2}}$ . No other Springers were recorded on that 1840 tax list.

- FLACK: (Also spelled "Flach"). Bartholomew (1811-1893), b. in Germany; md. Elizabeth E. Hertzel in 1833; moved to Schuyler Co., Ill. in 1839; to this county, 1849; had the following children: John, Elizabeth J., Alexander, William, Margaret, and Jacob. Also living in the household in 1860, was Mary Flack, age 12 years, a native of the State of N. Y.
  - Ora E. (1879-1881) was a son of Jacob W. and Mary Bell (Cordell) Flack; Ora was a brother to Edward L. & Rosa May.
- HUSHAW: Jonas (1814-1889), b. in Ross Co., Ohio in 1814; moved to this county in 1839; md. Oct 29, 1839, to Matilda Jane David, a native of Ky.; they had no children, however, adopted a girl -- Mary Jane, b. in Ind., 1847 (later was Mrs. David C. Harris); also raised another child, George Pearson, b. in Ind. in 1853. Jonas appears on the 1840 county tax list as # 479. He owned \$145.00 worth of horses, \$10.00 cattle, and \$45.00 in other property; taxes were \$1.00. Also listed on this tax report was John Hushaw, who owned 160A, the SE of section 13, Industry Twp.
  - Matilda J. (1820-1894), b. in Ky.; daughter of Abraham and Elizabeth David.
- MATHENY: Alexander (1817-1872), b. in Ky.; in June, 1860, his household in Industry Twp. consisted of the following individuals: Mike (age 23, b. Ill); Andrew (21); John (17); Wm. (15); Sarah (13); Joel (11); Morgan (9); and Charles (4).
- MEADOR: Jesse (1807-1865), native of Franklin Co., Va.; son of Watts Meador; lived in Tenn. prior to moving to Ill. in 1833; then moved to Gallatin Co., Ill.; thence to Schuyler Co., Ill. about 1837; to this county about 1849.

MEADOR (cont'd): Nancy (1812-1859), wife of Jesse; native of Franklin Co., Va.; daughter of George Chuning; Jesse & Nancy had 6 children, including twins.

George C., father of Elvira S. (1854-1863); a twin, and son of Jesse & Nancy Meador. Geo. md. Mary A. Pittman, native of Todd Co., Ky., Feb 15, 1849; they had the following children: Eugene B., Emma, Jesse, Palastine, Jennie, Alice, Ona, Ina, and Elvira.

PENNINGTON: J. S. (1828-1832), William (1826-1850), and an infant son were children of Thos. J. and Polly H. (Vanters/Vawter) Pennington. Both parents were natives of Ky. After her death in 1840, Thos. md. Mrs. Mary J. (Smithers) Rogers in April, 1841. Ulissus and an infant son were children of Thos. and Mary Jane. Both Thos. and his second wife are buried in the Pennington family cemetery in Industry Twp.

PITTMAN: William (1805-1881) b. in N. Carolina, son of John; the family moved to Christian Co., Ky., in 1808; thence, in 1812, to Bedford Co., Tenn.; returned to Ky. in 1817; Wm. md. in Ky. to Nancy Wyatt; moved to Morgan Co., Ill. in 1828; to this county, 1835; lived in section 24, Industry Twp.; later farmed on section 26, Ind. Twp.; Nancy Pittman was a native of Tenn.; Wm. & Nancy had the following children: Burris E. (1826); Polly Ann (1828); Wm. R. (1830); George Monroe (1832); Emily (1834); Elizabeth (1835); Jane (1837); Iva (1839); Henry Clay (1843); Harrison (1845); Taylor (1847); and John T. (1850). After the death of Nancy in 1863, Wm. md. the widow of John Rose; she was a daughter of Elijah M. Wilson of Schuyler Co., Ill.; Wm. and his second wife had a son, Freddy (b. 1865). Wm. appears as # 492 on the 1840 county tax list. He owned 40A in the SW4 of section 23, Industry Twp.; \$180.00 worth of horses, \$165.00 cattle, \$10.00 clocks and watches, \$40.00 wagons, \$200.00 cash loaned out, and \$170.00 in other property; total taxes were \$4.83.

Nancy (1861-1865) was a daughter of George Monroe & Esther. Pittman; George was b. in Ill.; Esther, in Ind.; a son, Wesley, was also b. in Ind. in 1859.

The infant son listed under the Pittman's was a child of Burris E. and Julia (Cressman) Pittman). Burris was an artist and several drawings by him appear in the 1871 McDonough County atlas. Other children of Burris & Julia were: Wm. (b. 1840); Emily (b. 1852); Grove (b. 1854); Ella (b. 1856); Eudora (b. 1858); and Mary (b. 1860.).

POWELL: Mary J. was a daughter of John J. and Elizabeth Wyatt; she was b. in Todd Co., Ky.

SEAWARD: William (1782-1849) and family appear in the 1830 federal census as living in Industry Twp.; the family consisted of a female under 5 years of age; a male between 5-10 years old; 2 males & 1 female between 20-30; a female, 30-40; and Wm., aged between 40-50 years.

SEAWARD (cont'd): William appears as # 505 on the 1840 county tax list. He owned 50A in the NW of section 25, Industry Twp.; also, \$10.00 worth of horses, \$10.00 cattle, \$10.00 clocks & watches; and \$21.00 in other property; taxes were \$1.51. Also appearing, as # 498, on that list, was John Seaward who owned 80A in section 16, Eldorado Twp.

SPRINGER: Jane (1809-1845), wife of Lewis; Mr. Springer appears on the 1840 county tax list as # 496. He owned 320A in section 26, Industry Twp. and resided in the SEZ of that section; also owned \$120.00 worth of horses, \$112.00 cattle, \$10.00 clocks and watches, \$50.00 wagons, \$12.00 cash loaned out, and \$219.00 worth of other property; taxes were \$9.02.

TOMBERLIN: James B. (1809-1854) b. in Virginia; son of Celia, referred to as "Widow" Tomberlin in local histories; Celia & family moved to this county in 1826 & were among the first settlers to arrive in this area; the family lived near the "Crossroads" in Industry Twp. James md. Clarissa "Clarkey" Hays in this county on Jan 12, 1832; they had the following children: Lacy (1832); Celia (1834-Mrs. Robt. Outlaw); Priscilla (1837); Mary (1838); Elizabeth (1841-Mrs. Asa Sellers); Fountain C. (1844-45); Martha E. (1845); Susannah (1847-Mrs. Stewart Pennington); and James F. (1852). James had a brother, Fountain C., b. in about 1811. James B. appears as #491 on the 1840 county tax list. He owned \$60.00 worth of horses, \$20.00 cattle, & \$58.00 in other property; taxes were \$.69. After James' death, his widow continued to live on the family farm south of Industry till her death in 1879; she and several members of this family are buried in Industry Cemetery.

WYATT: John J. (1813-1865), a native of Ky.; md. Elizabeth, a native of Tenn.; had the following children living in the household in 1860: Wm. (b. 1841); Andrew (b. 1843); Daniel (b. 1847); Sina (b. 1851); and Thos. (b. 1853). John J. Wyatt appears as # 493 on the 1840 county tax list; owned \$20.00 worth of cattle, \$10.00 clocks and watches, and \$42.00 in other property; taxes were \$.36.

#### Vail Cemetery

Location: Industry township, SW1, section 14; on the east edge of the Industry city limits, south side of the road.

Remarks: Neglect and vandalism have caused this family graveyard to deteriorate to near oblivion. The partially fenced grounds are covered with brush, weeds, briars, small trees, The stones and their inscriptions are in surprisingly good condition. However, nearly all of them have been pushed from their original positions. Large stones, some weighing several hundred pounds have been toppled from their bases and are lying in deep underbrush. This survey was made in March, 1975.

ARNOLD: Ira, father of Edward & Charles, lived on section 21, Industry Twp.; he was a native of Ohio and came to this county from Fulton Co., Ill. in 1857. Mr. Arnold enlisted in the Union Army in Bethel Twp. on Aug 14, 1862 and served as a private till his discharge on Jun 13, 1865.

DOWNEN: David (1830-1865) b. in Ill.; he and his wife, Minerva Jane, had several children, all b. in this county, including: Brazil (1857), Florence (1856), and Gideon(1859).

Minerva Jane, widow of David, married Michael Lawyer in this county in 1868.

Samuel (1831-1861), b. in Ill.; wife, Mary, b. in Ohio, 1835.

Johnson (1805-1855) appears on the 1830 federal census of Schuyler-McDonough County; at that time his family consisted of a wife and 3 sons under the age of 5 years. Mr. Downen appears on the 1840 McDonough Co. tax list as # 452. He owned: 160A, the SE of section 15, Industry Twp. (the present south half of the city of Industry); value of the land was \$4.00 per acre. He also owned, in 1840, \$180.00 worth of horses, \$45.00 cattle, \$75.00 wagons, and \$190.00 in other property; total taxes were \$5.65. In 1846, Mr. Downen gave an acre of his ground to a blacksmith, John Price, in order to entice the man to begin a business in that area. That blacksmith shop was the first business in that immediate vicinity, and was the beginning of the city of Industry.

JANES: Jesse (1820-1904), son of Walter and Ardra (Crook) Janes, both natives of Ky.; the family moved to this county in 1834, settling in Industry Twp.; Walter died in 1853; Ardra died in 1881; on Dec 31, 1846, Jesse md. Perlina Vanter; they had 5 children: William D., Sarah E., Harriet J., Mary M., and Thomas C. Perlina d. Apr 15, 1860; Jesse remarried on May 21, 1861, to Elizabeth Vail, a daughter of Thos. Vail; Jesse and Elizabeth (Vail) Janes had 2 children: Walter V. and Luella. Walter, father of Jesse, died in 1853; he is listed as # 448 on the 1840 county tax list; he owned 160A, the NW4 of section 20, Industry Twp.; also \$550.00 in personal property.

PRICE: Nancy (1784-1862), wife of Sam'l; a native of N. Carolina; in 1860, Sam'l & Nancy were living with Henry Downen in Industry Twp.; Henry was b. in N.C. in 1815; also in that household in 1860, were Thomas and Johnson Downen, ages 14 and 11. Nancy was the second wife of Sam'l Price; his first wife died in Ark. in 1834. Sam'l Tater moved to Rushville, Ill. where he died in about 1877 at age 91 years.

TEETS: Alpha (1831-1906), b. in Preston Co., W. Va., a son of Adam & Elizabeth (Mosser) Teets; the parents were natives of

Va.; Adam was b. in 1790; Elizabeth, on Jul 13, 1793; Adam & Elizabeth were md. in 1813; Mr. Teets d. in 1865; Mrs. Teets d. in 1869; Alpha moved to this county in about 1853 and worked as a farm hand for 2-3 years; on Mar 6, 1860, Alpha md. He owned 149A in sections 14 & 15, Industry Twp.; also \$110.00 worth of horses, \$64.00 cattle, \$10.00 clocks and watches, \$60.00 wagons, and \$287.00 in other property; taxes were \$6.08; his residence was located in section 14.

John B. (1811-1898), son of Thos. & Nancy Vail; b. in Butler Co., Ohio, Dec 18, 1811; John had a twin sister that died in infancy; the family moved to this county in 1834; before leaving Ohio, John md. Sophia Brown, onMay 11, 1834; John & Sophia farmed in Schuyler Co. for about 2 years, then moved to this county and lived on section 14, Industry Twp.; they had 9 children: Mary, Nancy, Christopher, Thos. J., Adaline, Lavina, Eliza, and William.

Thomas J. (1839-1863), son of John B. & Sophia (Brown) Vail; enlisted as a private in the Union Army on Aug 9, 1862; died at Nashville, Tenn. in 1863.



George (1819-1885), b. in Ohio; md. there to Matilda Brown; son, John R., b. in that State; moved to Ill., 1850; lived

BENNETT (cont'd): in Industry Twp.; after the death of his wife in 1860, Geo. then md. Maria ---; they had a daughter, Belle, who later md. a Mr. Hiller & moved to Knox City, Mo. Geo. Bennett was killed in 1885 by a runaway team of horses.

BOTCHLETT: B. F. (1833-1895), b. in Pa.; came to this county in 1854; operated a boot & shoe business in Industry.

Elizabeth (1839-1909)(Obit, in part, from The Macomb Daily Journal, Mar 5, 1909): "Mrs. Elizabeth Botchlett died at her home in Blandinsville, Mar 3, 1909, at 12:30 p.m. Elizabeth McKelvey was born in Franklin Co., Pa. Dec 19, 1838, being 70 years, 2 months, and 14 days old. She came to Illinois about 30 years ago and has lived in Blandinsville most of the time. She was married to Adam Botchlett about 45 years ago and to this union three children were born, one dying in infancy, the two children living are George of Rock Island. Ill. and Mrs. Lee Wilson of Blandinsville..."

BRIDGES: John (1797-1844), b. in N. C.; md. Margaret Vance in the State of Tenn. in 1816: moved to Morgan Co., Ill., 1823; to this county, 1829; lived in Industry Twp. The 1830 federal census indicates the Bridges family consisted of the following members: 6 girls under age 15 years; a boy between 5-10 years old; a male between age 20-30; and a male between 30-40 years; 2 females, one aged between 30-40 years, and another between 50-60. Mr. Bridges appears as # 462 on the 1840 county tax list. He owned 80A in the NE½ of section 14, Industry Twp.; also \$135.00 worth of horses, \$65.00 cattle, \$10.00 clocks & watches, \$10.00 wagons, & \$170.00 in other property; taxes were \$3.95.

BURNHAM: Edgar (1865-1923). Charles Edgar Burnham was b. in Schuyler Co., Ill. Oct 3, 1865, a son of Edgar & Caroline (Armstrong) Burnham; Edgar, Sr., b. in N. Hampshire; Caroline, a daughter of John Armstrong, natives of Pa.; Edgar, Jr. was the 4th of 14 children b. to his parents; the family moved to this county in about 1872; Charles Edgar had a brother, John; on Feb 7, 1894, Edgar md. Minnie Wilson, a native of Industry Twp.; they had 4 children: Hugh Wilson, Edgar Wilson, Roy King, and Carl Hobart.

Minnie (1868-1942), wife of Chas. Edgar Burnham; a daughter of Hugh and Harriet (Hobart) Wilson.

CARNAHAN: James H. (1812-1886), a son of Aaron & Elvira (Mitchell) Carnahan, of Ohio; Aaron b. in Tenn.; Elvira, b. in Ky.; James b. in Clinton Co., Ohio; md. Aug 25, 1836, to Cynthia A. Murphy; moved to Ill. in 1852; Lived in Scotland Twp., this county; also lived in Mason Co., Ill., then moved to section 11, Industry Twp.; had 7 children: Anna M., Chas. J., Safronious, Sarah A., Benjamin, Lafayette K., & Mary I.

- CARNAHAN (contid): Benjamin M. (d. 1876); killed enroute to the West; a gun discharged after he jumped from a wagon at Coatsburg.

- D'CAMP: Joel (1797-1848) b. in Pa.; md. Matilda Bridge in Ohio & moved to Fulton Co., Ill. in 1839; thence to this county in about 1847; farmed in Eldorado Twp. A daughter of Joel & Matilda, Elizabeth, md. Wm. Legere in 1858; Wm. was killed in Louisiana during the Civil War; Elizabeth then md. Chas. F. Skiles, who died in 1876.
- DUNCAN: Basil A. (1825-1877), b. in Frankfort, Pa., Apr 6, 1825; studied medicine in Pittsburgh; md. in 1845, to Julia Standard; moved to this county, 1849; practiced medicine in Industry for 28 years; after the death of his first wife in 1863, Dr. Duncan then md. Martha Merrick, Nov 8, 1864. Martha (Merrick)

- DUNCAN (cont'd): Duncan md. J. Barnett Standard after the death of Dr. Duncan.
- GOBLE: James D. (1814-1894), b. in N. J.; a shoemaker by trade; md. Amanda Danley; lived in Whitney Co., Ind. before moving to this county in 1868; had 13 children including Edward Durphy Goble, b. in Ind. in 1862.
- HINSHAW: Jesse B. (1839-1894) d. at Industry. His sister, Tamar Hinshaw, cared for him prior to his death.
- HUSHAW: John (1801-1875) moved to this county in 1838; wife was the former Tamar Conner; children included: Sam'l (1825); Henry (1828); Ellen (b. in Ind., 1837); John (b. in Ill., 1838); Joseph (1842); Jesse (1843); Elizabeth (1845); and Isabel (1847). John Hushaw appears as # 479 on the 1840 county tax list. He owned 160 acres, the SE½ of section 13. Industry Twp.; also \$100.00 worth of horses, \$220.00 cattle, \$50.00 wagons, & \$132.00 in other property; taxes were \$5.71.

Henry (1828-1902), son of John & Tamar (Conner) Hushaw: b. in Fountain Co., Ind.; moved with parents to this county in 1838; md. May 3, 1860, to Emily J. Little of Fulton Co., Ill.; had 6 children: Mary A., Charles R., Athie E., Sam'l P., Addie, and J. Evert.

KEE: Samuel (1847-1929) b. in Cochocton Co., Ohio; son of Wm. & Mary (Fisher) Kee; Wm. b. in Md.; Mary, a native of Browns-ville, Pa.; paternal grandfather, Andrew Kee, b. in Md.; maternal grandfather, Jacob Fisher, from Pa.; Wm. Kee & family moved to Fulton Co., Ill. then to this county in about 1854; lived in Eldorado Twp.; Sam'l the youngest of 7 children, md. Mar 28, 1876, to Edith E. Marshall; Sam'l then bought a farm across from his father's place in Eldorado Twp.

Edith E. (1853-1923), b. Vermont, Ill.; daughter of John S. & Harriet (Asher) Marshall; John, b. in Cadiz, Ohio; he d. in Vermont, Ill.; Harriet b. in Paducah, Ky., d. Feb 8, 1890; Edith's paternal grandparents were Wm. & Sarah Marshall. (Obit in part, from the Macomb Daily Journal, Apr 5, 1923): "Edith Ermine Marshall, second daughter of John & Harriett (Asher) Marshall, was born near Vermont Mar 21, 1853 and died at her home, four miles east of Industry, on Saturday, Mar 31, 1923, being 70 years and 10 days old. Death came as a result of a stroke of paralysis, suffered in March, 1920 .... married Samuel Kee on March 28, 1876 .... Of her father's family she is survived by one sister, Mrs. Helen McFadden, and one brother Robert Marshall. A sister, Theodosia Edie, died in 1911 their home was never blessed with children. For many years she was mother in fact though not in name, to Leta Easley, now Mrs. Liver Rauch, and Edith Easley, both now residents of Chicago..."

William (1806-1882), b. in Md.; wife, Mary, from Pa.; had 7

Michael (1832-1898) (Obit, in part, from The Macomb By-Stander, Aug 31, 1898): "Another of the few remaining pioneers of Mc-Donough county passed away in the death of Michael Lawyer, which occurred Saturday, Aug 27, at his late home in Industry, after an illness of some time ..... Michael Lawyer was born in Fayette Co., Ohio, Sep 22, 1832, and lived 66 years, less 25 days. He was a son of John & Massie (Cooper) Lawyer, the former a native of Virginia and latter of Ohio. In 1837, he came, with his parents to Industry township, where they lived two years and then moved to Eldorado township. He and Sarah E. Kee were married on Sep 27, 1857, and to them four children were born, the sole survivor being William K. Lawyer of Scotland township. This union was separated by death in 1865. In 1868, deceased was united in marriage with Manervia Downen, widow of David Downen, and to them were born four children, John W., and Katie M., being the survivors. The wife also survives ..... ". Mr. Lawyer's first wife, Sarah, and some of his children are buried at Chockley Cem.

MATHENY: Sarah (1859-1921) (Death notice, in part, from The Macomb Daily Journal, Nov 3, 1921): "Mrs. G. M. Matheny died at her home three miles southeast of Industry Tuesday evening at 9:00 o'clock, aged 62 years. Death was caused from aenemia, with which she had been a suffered for many months....".

MERRICK: John D. (1843-1903)(Obit, in part, from The Macomb Times, Jan 22, 1903): "John D. Merrick ... died at 12:30 o'clock last Friday night at the home of his daughter, Mrs. George Standard in Eldorado township, of general debility, aged 60 years; 7 months, and 10 days. Deceased was born June 6, 1842; in Oct., 1866, was united in marriage with Mary C. Leach. He served during the Civil War and was wounded in the battle at Kenesaw Hountain. His brother; Charles, was killed in battle at Bentonville, Ga. - SHANNON: William (1804-1866), b. in Tenn., Sep 12, 1804; son of Chas. Shannon who d. in 1858; Wm. moved to this county in 1830 from Knox Co., Tenn.; md. here to Mary Miller on Jan 12, 1832; raised 9 children: Rachel A., Elizabeth A., Nellie E., Chas. R., John F., James P., William H., Harvil M., and George G.
- STANDARD: Gideon (1800-1867). G. T. b. in N. C.; wife, Sina, b. in Tenn.; the following children b. in Ill.; Geo. (1841); Ellen (1844); Martha (1847); & Lucy (1848). Mr. Standard appears as # 486 on the 1840 county tax list. He owned 240A in sections 23 & 24, Industry Twp.; also had \$150.00 worth of horses, \$120.00 cattle, \$10.00 clocks & watches, \$50.00 wagons, and \$241.00 in other property; taxes were \$8.86; residence was in the SW2 of section 24, Industry Twp.
  - J. B. (1824-1889); John Barnett Standard b. in Ky., son of Gideon T. & Sina (Wyatt) Standard; moved to Morgan Co., Ill. in about 1832; to this county, 1836; lived in Industry Twp.; J. B. md. in 1849, to Jane Allison, daughter of John Allison; they had 9 children: Mary (Mrs. Jerome Jones of Scotland Twp.); Margaret (Mrs. Thomas Jones of Clay Co., Nebr.); Julia (Mrs. E. F. Wheeler of Kansas City); Malinda (Mrs. Geo. W. Russell of Bethel Twp.); Gideon; John; George; Matilda; & Andrew J. After the death of his wife, Mary Jane, in 1876. J. B. then married Martha Lucy (Merrick) Duncan, widow of Dr. B. A. Duncan; J. B. and his second wife had 2 children: Fannie & Ethel.
- SULLIVAN: Sarah & William, children of Henry C. & Catharine M. (Vance) Sullivan. Henry, a son of Wm. & Sarah A. (Adkisson) Sullivan, b. Nov 10, 1841, in Industry Twp.; Henry & Catharine had 8 children: Rosa C.; Sarah E.; Wm. A. & Eliza A. (twins); Nellie; Forest H.; Florence C.; & Lena. Henry was a brother

SULLIVAN (cont'd): to Thos. D. Sullivan; they operated a hardware business in Industry till 1894.

VANCE: James (1764-1835), b. in Franklin Co., Tenn.; moved to S. Carolina, then to this county in 1826; lived on section 24, Industry Twp.; md. Margaret Ramsey, native of Tenn.; they had 12 children. Mr. Vance held several county offices during the early 1830's and was Commissioner of School Lands when he died in 1835; Mr. Vance was the first to be buried in this cemetery. On the 1827 Schuyler-McDonough county tax list, Jas. Vance is shown to own \$212.00 worth of real & personal property; his taxes were \$1.06. On the 1830 federal census for Industry Twp., the James Vance household was as follows: 1 male 20-30 years old; 1 male between 60-70 years old; 2 females between ages 30-40; and a female between 60 & 70 years old. On the 1840 county tax list, Margaret Vance, widow of James, Sr., is shown as # 478; she owned \$75.00 worth of horses.

James, Jr. (1807-1872) appears on the 1840 county tax list as # 477; owned 120 acres in section 13 & 14. Industry Twp.; also \$100.00 worth of horses, \$80.00 cattle, \$10.00 clocks & watches, \$30.00 carriages, \$30.00 wagons, & \$212.00 in other property; taxes were \$5.31. Residence was in the south half of the NE2 of section 14, Industry Twp.

WILHELM: Andrew J. (1833-1909) b. in Ark.; moved to this county in 1854 from Schuyler Co.; farmed on section 11, Industry Twp. A son of Welcome & Mary Wilhelm. He & Sussana's children included: Florence (1857); John (1859); and twins - Douglas & Johnson (b. 1860).

Susanna (1837-1864), wife of Andrew; daughter of John & Martha (Vance) Wilson. Susanna was a sister to Elizabeth A., Mary V., Hugh, Sarah V., James V., W. V., Christopher, Lewis R., Rufus R., Martha R., and Margaret R. V.

WILSON: John (1806-1886) son of Hugh; b. in Jackson Co., Tenn., Nov. 2, 1806; moved with the family to Christian Co., Ky.; then to Mo.; to Schuyler Co., Ill. in 1825; and to this county in about 1827. Md. Martha R. Vance, Oct 30, 1828; that was the first marriage recorded in this county. On the 1830 federal census of Industry Twp., the John Wilson family consisted of John, his wife, and a daughter, under 5 years old. On the 1840 county tax list, John appears as # 451. He owned 120 acres in the NW1 of section 13, Industry Twp.; also, \$100.00 worth of horses, \$112.00 cattle, \$80.00 wagons, and \$186.00 in other property; taxes were \$4.19. The children of John & Martha R. Wilson were: Elizabeth Ann (1829); Mary V. (1830); Hugh (1832); Sarah V. (1833); James Vance (1835); Susannah (1837); W. V. (1838); Christopher (1839); Lewis R. and Rufus R. (twins-1841); Margaret T. (1843); and Martha R. (1845). Lewis & Rufus served for 3 years during the Civil War.

WILSON (cont'd): Hugh, father of John Wilson, died in Iowa. He was considered to be a true pioneer and John's mother apparently enjoyed the frequent moves to unsettled areas. She was quoted as saying that "the food always tasted better when they were moving." Hugh and his family moved from Tenn. to Ind. to Mo., and in 1825, to Schuyler Co., Ill.; in 1826, they moved to this county; son, James then went on his own and settled in small cabin on section 9 in about 1826; he and his family stayed there thru one harvest season, then moved on to Des Moines rapids; the latter move was reportedly caused by Indian threats.

Hugh (1832-1912), son of John & Martha (Vance) Wilson; b. in this county; md. Harriet Hobart, Jan 14, 1855; Hugh & Harriet had the following children: Nancy Ann (Mrs. W. P. Skiles moved to Nebr.); Milo; Traverse (moved to Nebr.); Marilla B. (Mrs. J. P. Young); Mortimer; Carr (moved to Calif.); Edward (moved to Colo.); Minnie (Mrs. C. E. Burnham); Carrie; Guy; Roy (moved to Alma, Nebr.); and William (moved to Hedrick, Okla.).

Harriet (1835-1910), wife of Hugh; daughter of Wm. & Achsah (Ingraham) Hobart; Wm. was b. in Ireland; his wife, in N. Y.; the Hobarts moved to this county in about 1850; then moved to Iowa in 1859, and both died there. Harriet was the third of a family of 11 children.

James Vance (1835-1921), b. Dec 11, 1835; sonof John & Martha (Vance) Wilson; b. in this county; md. Jan 22, 1856, to Permillia Adkisson, native of this co.; had 2 children: Paris (1856-1858) and Thomas. Permillia d. Feb 10, 1858; on Oct 11, 1958, Jas. Wilson md. Clara S. Adkisson; they had 14 children: John A. (1861); Leroy (1863); Amaranth (1865); Price (1867); Veronia (1869); Marguerite (1872); Eva (1874); Bernice (1876); Alva (1879); Nova (1881); Calvin & Melvin (twins-1884); and Dottie (1887).

William V. (1838-1908), son of John & Martha Wilson; md. Elizabeth Wilhelm; had a daughter, Kate (Mrs. Arda Chipman).

Elizabeth (1840-1910), wife of Wm. V.; daughter of Welcome & Mary (Price) Wilhelm; parents buried in Wilhelm Cemetery.

## Genealogical Notes - Wilhelm Cemetery

AGNEW: The Agnew children were those of Samuel and Mary (Wilson) Agnew, who came to this State in 1847; they lived near Rushville in Schuyler Co., and in Bethel Twp., this county. Samil was b. near Buffalo, N. Y., Jul 12, 1820; he d. at Macomb on Nov 7, 1879; Mr. Agnew was a stone mason by trade; he and Mary Wilson were md. Dec 16, 1849, at Industry; she was a native of Columbia Co., Ohio; Samil & Mary had 8 children; in addition to those listed in this cemetery there were: Milton P., Henry C., George T., and Josie A.

BUTCHER: Bersheba A. (d. 1869), wife of Preston; he came to this county in 1861 from Schuyler Co., Ill. Mr. Butcher was a native of Ohio; farmed in section 4, Industry Twp.

COCKERHAM: Mary C., wife of D. L., was a daughter of Joel & Elizabeth (Smith) Pennington; Mary was b. in Schuyler Co., Ill. in 1831.

HANKINS: Joel (1849-1850), son of A. J. & Lydia A. (Pennington) Hankins; A. J. was a son of Fielden Hankins, native of Tenn.; Fielden was b. in 1787, & came to this county from Coles Co., Ill. in 1834; he later moved to Hire Twp., this county, where he died in 1881; he was buried at Vermont, Ill. A. J.'s mother was killed by a runaway team of horses in this county. A. J. & Lydia A. were md. Aug 28, 1845; she was a daughter of Joel & Elizabeth (Smith) Pennington. Lydia A. (Pennington) Hankins d. in 1885, and was buried at Good Hope. A. J. later lived in Blandinsville, Ill. where he ran a harness business.

PENNINGTON: Joel (1803-1865), b. in Ky. and moved to Schuyler Co., Ill. in 1826, remaining there for 10 years; while in that county, Joel served as sheriff for 7 years; prior to coming to Schuyler, the Pennington's lived a short while in Franklin Co., Ill. The 1830 federal census for this county; indicates that the Joel Pennington household included 2 boys & 2 girls, all under the age of 10 years. Joel & Elizabeth Smith were married in Ky. on Mar 14, 1822.

When the 1830 federal census was taken, McDonough County was still considered a part of Schuyler, for records pur-

poses.

Donia, Manerva, Jabena, an infant, and Mary were children of David A. & Elizabeth A. (Sharman) Pennington; David was a son of Joel & Elizabeth (Smith) Pennington and was b. Oct 8, 1828, in Schuyler Co., Ill. David & Elizabeth were md. in 1853; she was a daughter of Wm. Sharman, an early settler of

PENNINGTON (cont'd): this county. David and his wife had 7 children; in addition to the 5 named above, they had: Ruan B. & Arthur H. This Pennington family lived on section 10, Industry Twp.

Allen (1814-1867), b. in Ky.; in 1860, he was farming in Eldorado Twp., this county; his household, at that time, consisted of the following members: Wife, Hannah (b. in Pa. in 1817); William (b. in Ill., 1839); Melissa (b. in Texas, 1841); John (b. in Ark., 1843); Thomas (b. Ark., 1844); Frances (b. Ark., 1846); Sarah (b. Ill., 1848); Joel (b. Ill., 1851); and Martha (b. Ill., 1853).

PRICE: Mary, Hannah, Samuel, and Sarah were childrenof Thos. J. and Eleanor (Wilson) Price; Thos. was a son of Samil & Bersheba (Atchley) Price; natives of Tenn. Thos. was b. in Meigs Co., Tenn., Feb 23, 1828; the family moved to Schuyler Co., In 1830; then to Washington Co., Ark. where Thos. mother d. in 1834; the remaining members of the family then returned to Ill.; Thos. md. Jul 6, 1848, to Eleanor Wilson, native of Ohio; they had 8 children; besides those named above, they had: William; George W.; John M.; and Edward E. This family moved to Industry Twp. in about 1850. Eleanor (Wilson) Price d. in 1869; Thos. then md., on May 18, 1876, Maggie Miller. nee Van Hoesen. Samil, father of Thos., later moved to Macomb, then to Rushville, where he died at age 91.

WILHELM(S): Welcome (1810-1871) was a son of James Wilhelm, Sr., a native of Tenn. Welcome b. in Meigs Co., Tenn.; moved to Washington Co., Ark. in 1830; to Schuyler Co., Ill. in 1833; on Jan 27, 1830, he md. Mary Price; they had 8 children, including: Andrew J. (b. 1833, in Ark.); Elizabeth (b. 1840 md. Wm. Wilson); Barshebe (1843); Jane (1846); and Mary (b. 1848). Welcome Wilhelm had 3 brothers: James Jr.; Jacob (moved to Ark.); and George (moved to Mo. & was killed

there by a stray bullet).

Mary (1807-1881), wife of Welcome; a daughter of Sam 1 & Barbara (Atchley) Price; b. in Tenn, Jan 26, 1807.
