## Preface

Within the boundaries of McDonough County, Illinois are more than a hundred cemeteries and gravesites ranging in size from a single burial site to the expansive Oakwood Cemetery at Macomb. Within these cemeteries are the remains of an estimated 40,000 individuals who have died since the first settler arrived here over 150 years ago. Graves of countless others are scattered over the countryside of McDonough County; but, exact sites of many of these resting places are no longer known for various reasons. During the early days of this county, there were obviously no central burial grounds; thus, a pioneer family having the misfortune of losing one of its members placed the deceased in a grave on a family homestead and erected a makeshift marker. A number of these family burial grounds later became public cemeteries, however, many of the grave sites soon became "lost". Crude wooden markers or a hand engraved stone soon succumbed to the elements and were never replaced; scores of families moved further west after staying in this area only a short time and the gravesites of their loved ones shortly became insignificant mounds of earth; a number of families passing through this vicinity suffered individual losses. A prime example of the latter is contained in a history of Bethel Township. In 1830, four children of an emigrant family died while enroute through McDonough County. They were buried near their places of death which occurred about two miles southwest of Fandon. All traces of those graves have long been gone. During the summer of 1834, a widow lady died at her home in northern Tennessee Township. Her coffin of dressed walnut lumber was built by a local cabinet maker and she was buried in the timber near her home. Within a few years, no evidence remained to indicate the presence of her final resting place. A family who created an excellent farm from the prairies a few miles north of Macomb, maintained a fenced family burial site for several years. This cemetery contained the graves of about 12 former family members. During the early 1900's, the farm changed ownership. Shortly thereafter, the new owner removed all the stones, took down the fence, and this graveyard became part of a cornfield. These are only three of the countless incidents involving the total disappearance of burial sites. At this time, it is impossible to determine the locations of hundreds of individual's graves in this county.

Vandalism is responsible for the destruction of many grave stones. Countless markers have been partially or totally destroyed. Inscriptions have been obliterated by shotgun blasts, stones have been broken into dozens of pieces, and some markers have been entirely removed from their original locations.

While weather-wear and vandalism accounts for most of the destruction of individual tombstones, neglect is directly responsible for the eventual deterioration of graveyards. Several local cemeteries have had no protective fencing for a number of years and the grounds have become grazing land for livestock. Groundhogs and other burrowing animals have undermined large portions of various cemeteries. Some areas are nearly invisible because of massive growths of weeds and brush. Stones have fallen, broken, and become completely covered with soil and debris.

The overall conditions of our county cemeteries is a pathetic case. While some grounds are well maintained, or at least partially kept-up by various families, many have been totally forgotten. This situation is appalling and should never have come about. Apparently, lack of time, expense, and most of all regard has brought about the present-day poor conditions of many of our rural cemeteries.

Genealogical notes accompanying the various cemetery listings were prepared from a wide variety of sources including: Local area history books and atlases; newspaper files; county, state, and federal archives; family histories. These notes were collected at random from readily available sources and little, or no attempts were made to search for material for more complete genealogies. These notes are presented only for the purposes of identification and/or clarification.

Every attempt has been made to present complete and accurate information. Readers will find errors and omissions. Others will not agree with portions of my findings; however, no information contained herein is based solely on assumption or guesswork. It must be remembered that this information has been prepared for use only as a tool for further research and that nothing must be taken as final and absolute.

The larger cemeteries contained in these volumes are accompanied by grave location charts. These charts in no way are intended to represent any professionally prepared plat or survey that may exist. Their preparation and presentation are solely for general location purposes.

When copying inscriptions from grave markers, it is sometimes impossible to read some portions of the engraving. Names, dates, ages, etc. that were found to be unclear or totally missing are indicated by the use of question marks or dashes, i.e., SPICER, James T., infant son of ?J.B. & S.J.??; d. -----; age -----. The letters or numbers enclosed in parenthesis following the inscription, indicate general location as indicated on the accompanying chart.

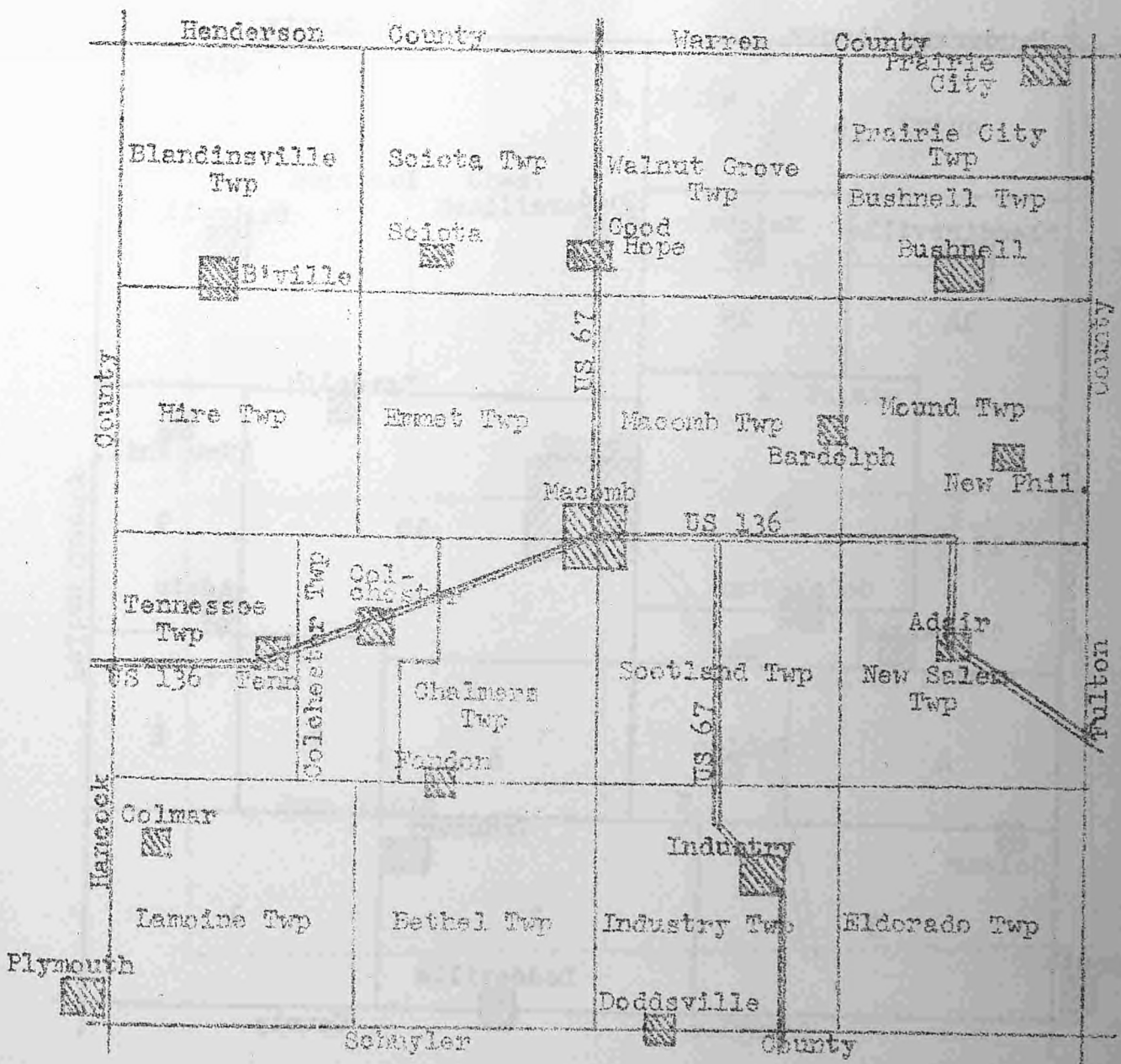

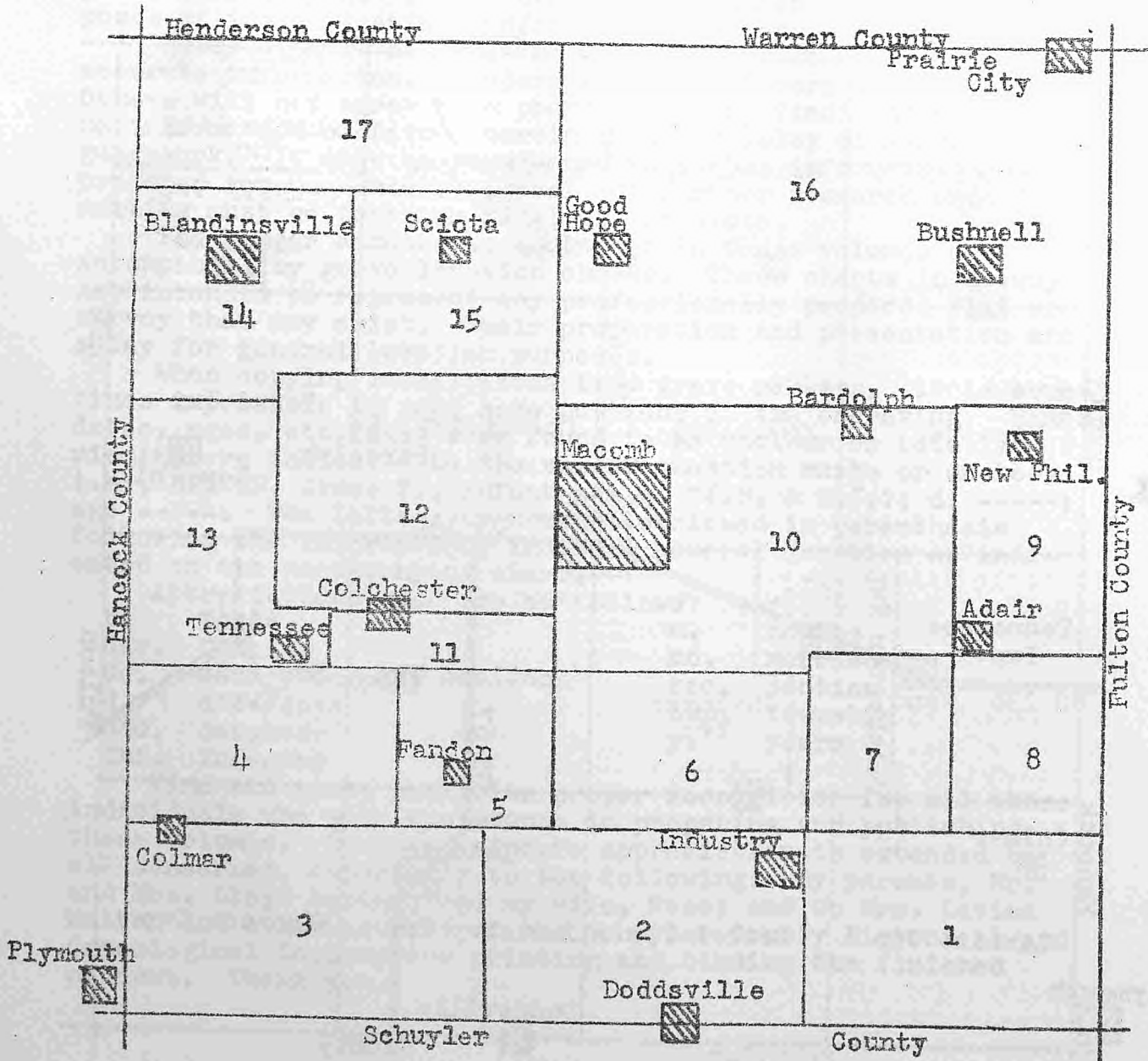

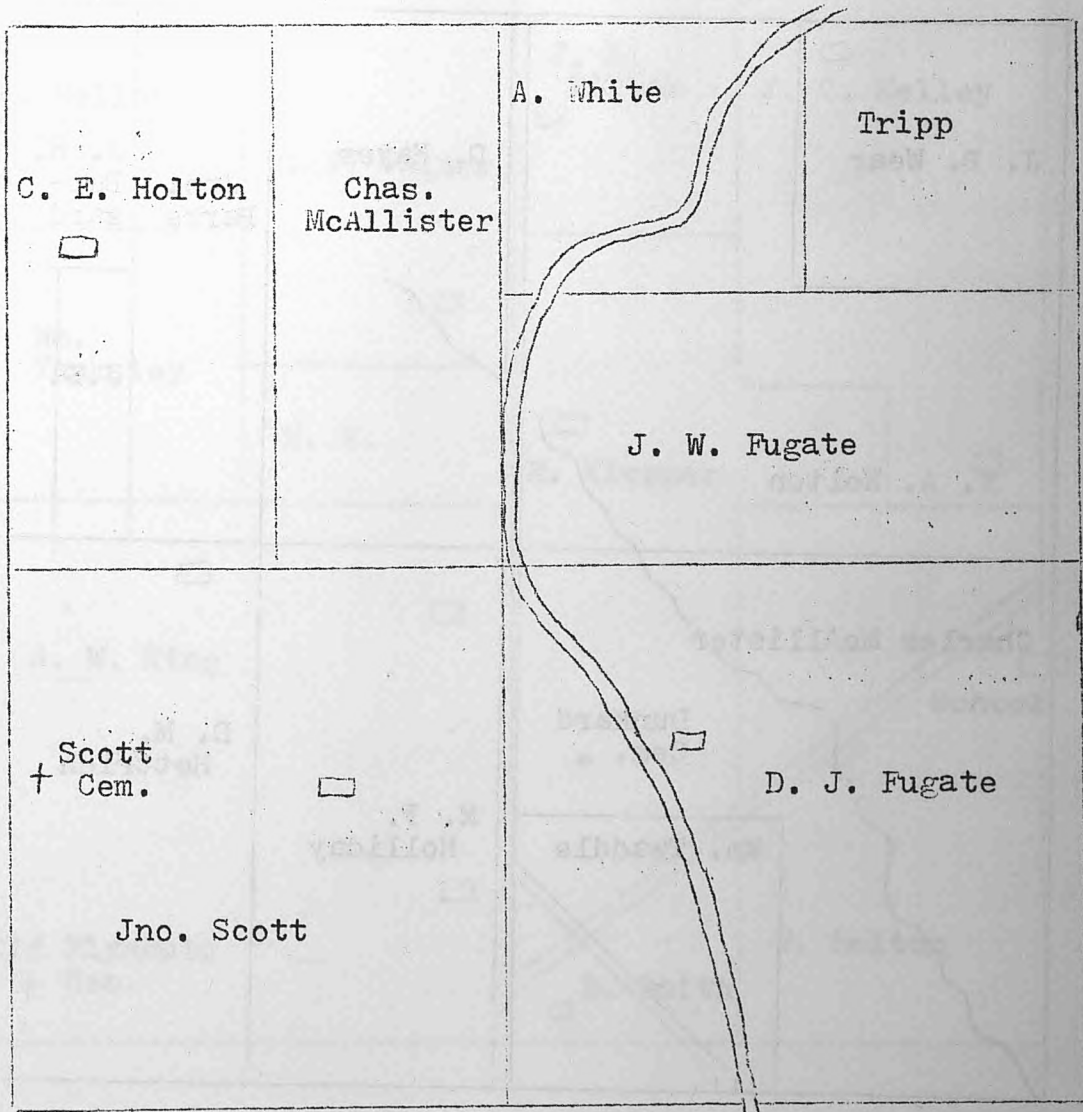


Areas covered by volumes I - XVII  
 "Cemeteries of McDonough County, Illinois"



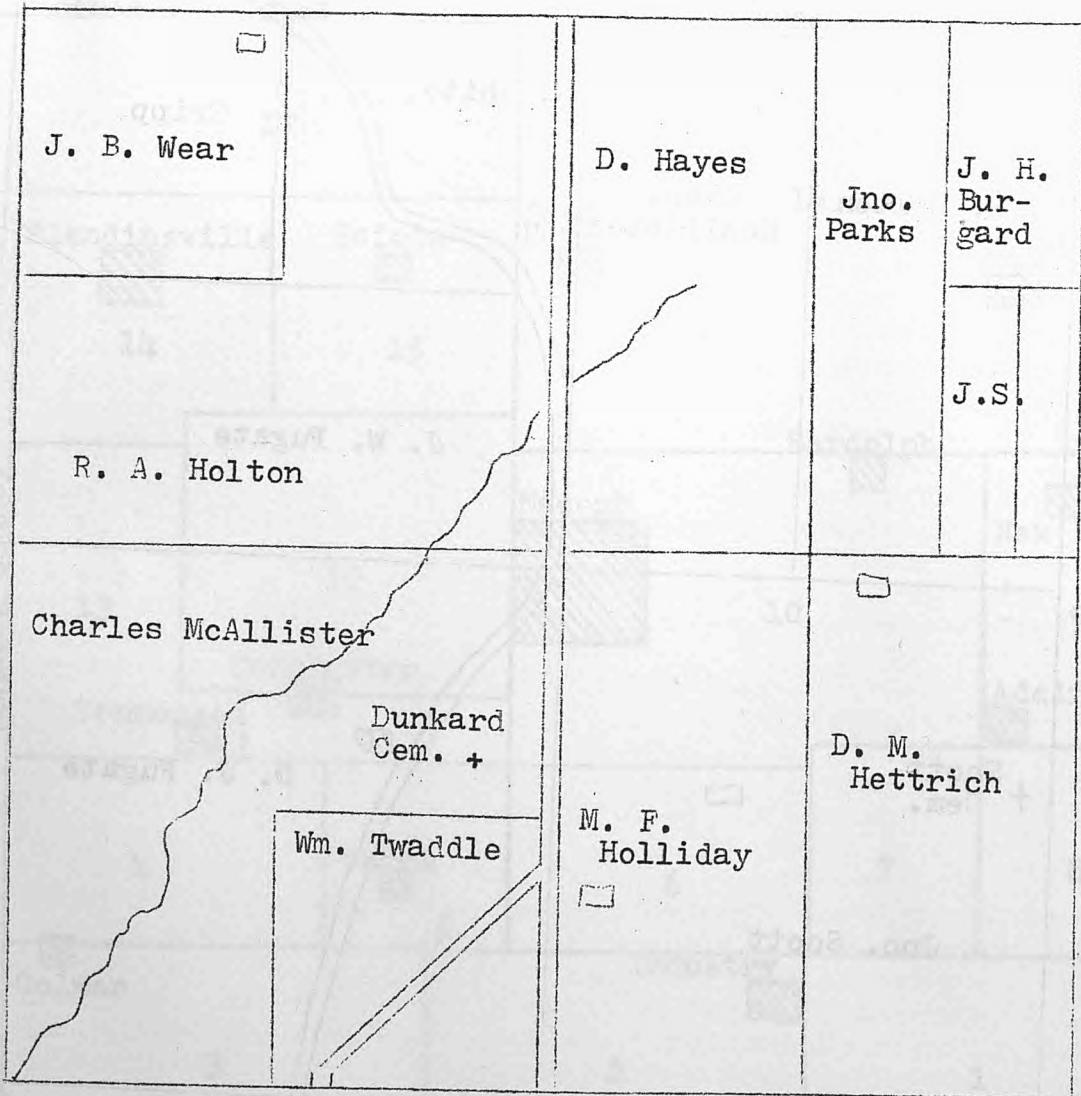
Section 30

Bethel Township, T4N R3W; 1871



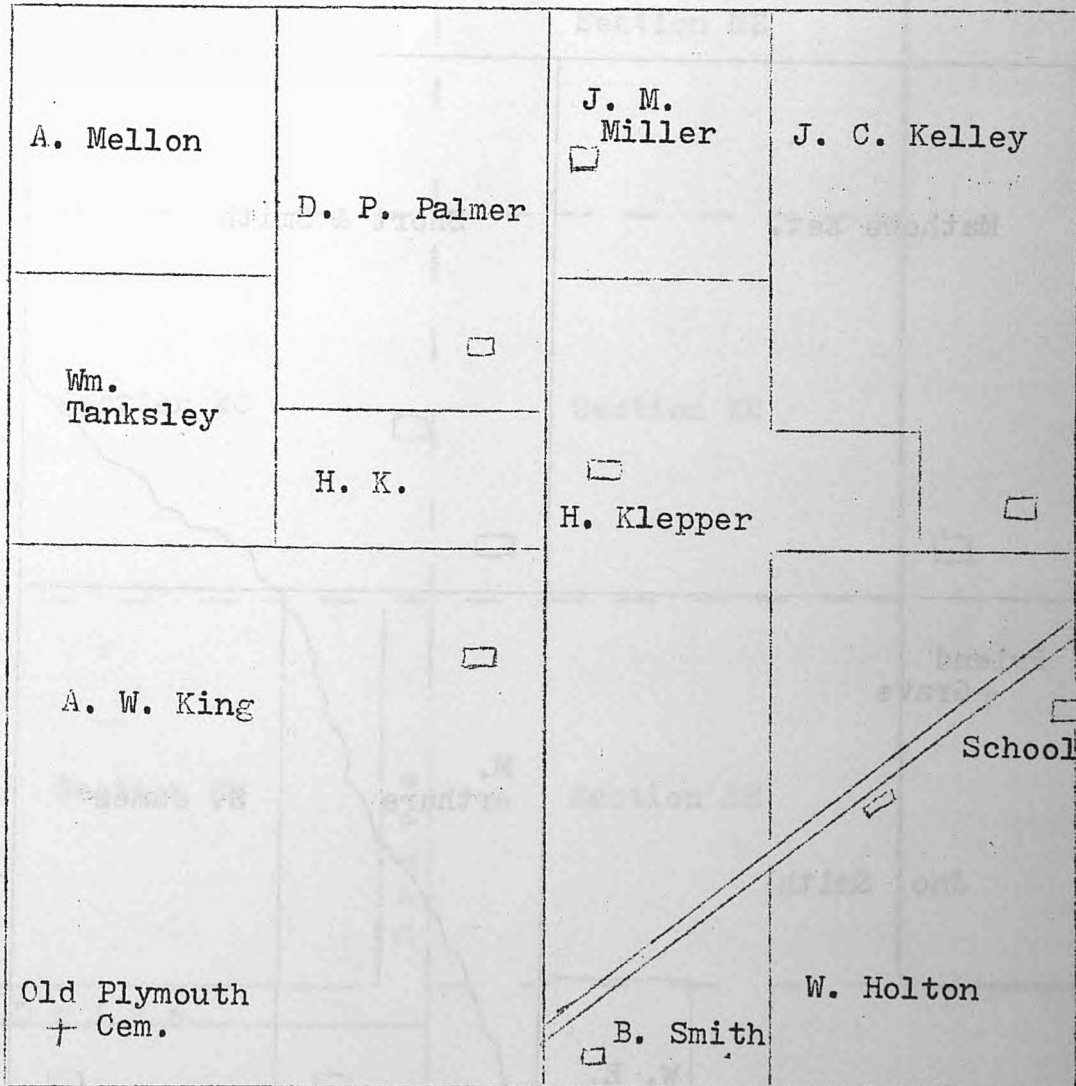

Bethel Township, T4N R3W; 1871



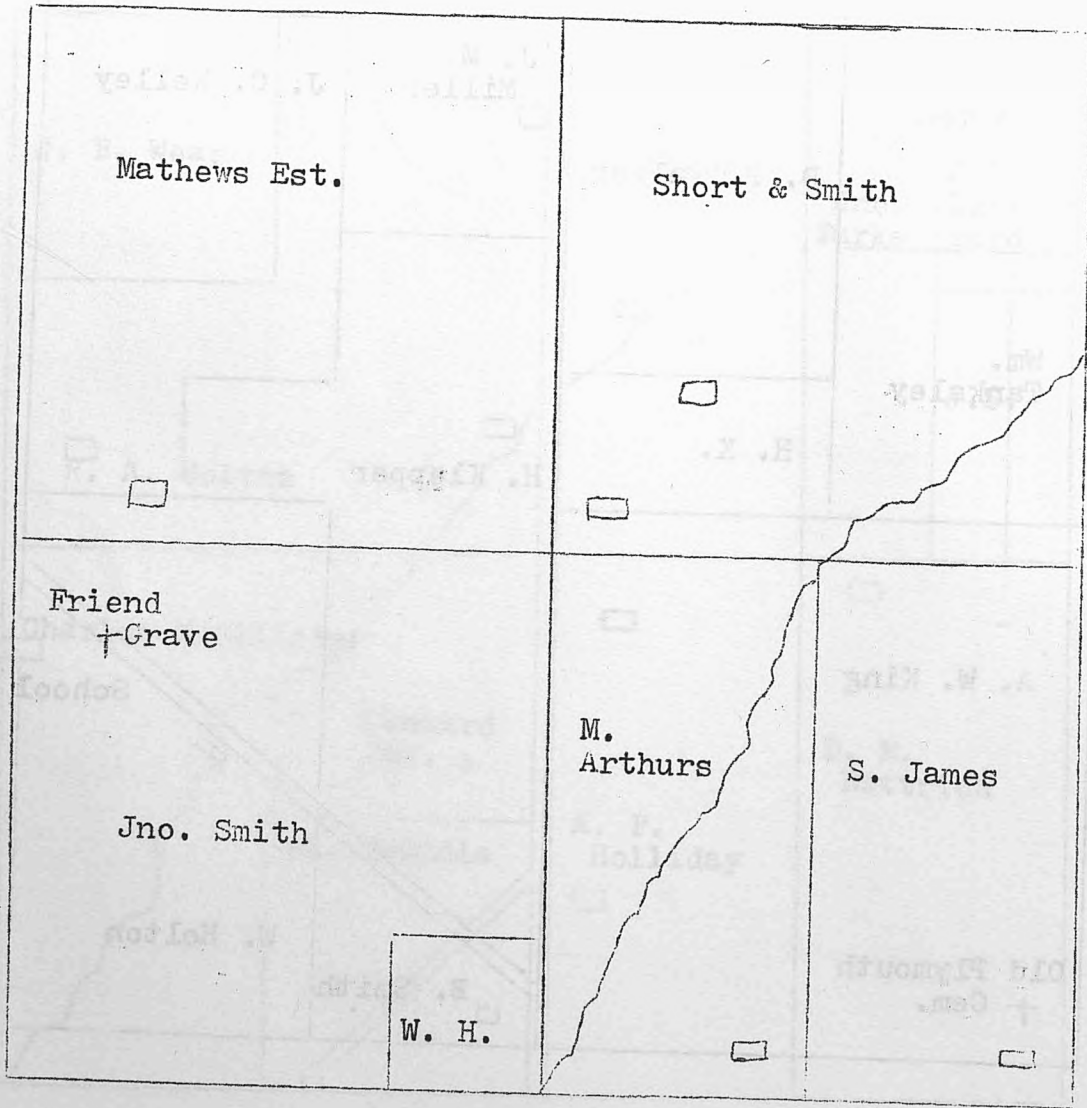

Lamoine Township, T4N R4W; 1871

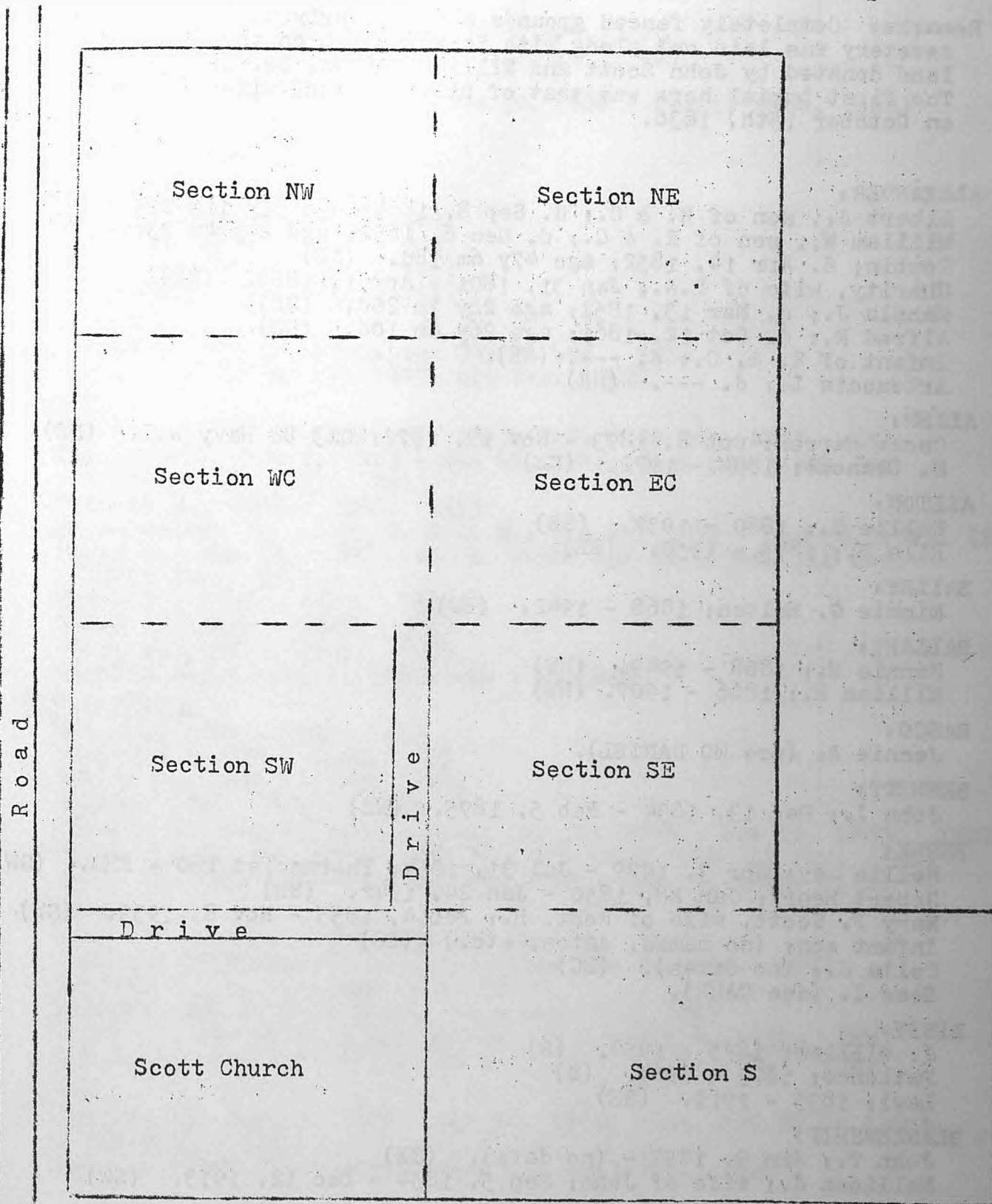

Scott Cemetery

Location: Bethel Township, SW $\frac{1}{4}$  Section 30; 2 miles west, 5 miles south of Fandon.

Remarks: Completely fenced grounds and regularly maintained. This cemetery was laid out along with Scott Church on three acres of land donated by John Scott and William Holton, Sr. in the 1830's. The first burial here was that of Olive Holton, wife of Wm. Holton, on October 15th, 1836.

BERRY: Robert Henry (1850-1942); b. in Va.; to this county in 1869; farmed on section 24 Lamoine Twp. Appears on an 1880 county census; his family, at that time, consisted of his wife, Mary S., and daughter, Nellie M., age 1 year. The family lived in Lamoine Twp.

BLANKENSHIP: John T. (b. 1857) appears on an 1880 county census living in Lamoine Twp.; the household included the following persons: Melissa (age 26); George A., 6; Arthur R., 3; and Mary A., 6 months.

BURRESS: Frank (Wm. Franklin) and Joseph T. were sons of Mrs. Jerusha Ann Burress; after the death of her first husband, Mrs. Burress married Thos. Shoopman in 1865. Joseph T. died on his 23rd birthday.

BUTTERFIELD: Caleb W. (1839-1902) b. Astabula Co., Ohio; moved to this county about 1850; enlisted Nov 20, 1861 at Middletown; re-enlisted and was mustered out Sep 30, 1865; died of heart failure in Birmingham Twp., Schuyler Co.

CASE: Addie (1859-1886), wife of Clarence; maiden name was Scott; b. in Lamoine Twp., this county; taught school in area rural schools; d. at her parents home in Lamoine Twp. of consumption. (Obit, in part, from The Macomb Journal, Feb 25, 1886): "Addie Scott Case died at the home of her father, Solomon Scott in Lamoine Twp., on February 20, aged 27 years. She was born in Lamoine Twp. on July 30, 1859 and married Clarence Case of Macomb on January 28, 1886. They lived 3 miles west of this city. She was a member of the M.E. Church."

CAVETT: Mary H. (1853-1939), daughter of Henry A. and Rebecca (Scott) Holton; b. in this county.

DAVIDSON: John B. (1838-1909) appears on an 1880 county census and was living in Lamoine Twp.; members of his household included: Hugh L., age 61; Mary E., age 35, wife of John B.; Mary E., 18, John A., 17; Frances, 14; Etta B., 10; Sarah A., 5; William S., 3; and Jesse M., 1.

- DUNCAN: Joseph (1828-1915); b. in the state of Tenn.; moved to this county, 1851, from Louisa Co., Ia.; lived on section 11, Lamoine Twp.; enlisted on Feb 25, 1864 at Mocomb and served a short time with Co D 124th Ill Inf.; later transferred to the 33rd Ill Inf.; mustered out Nov 24, 1865. Appears on an 1880 county census and was living in Lamoine Twp.; members of the Duncan household included: Martha, age 46; George, 23; Eldridge, 17; Frank, 15; Arthur, 13; Etta A., 12; Eugene, 4.
- FOLSOM: James (1791-1861) appears on the 1850 federal census for Woodstock Twp., Schuyler Co., Ill. He was born in N.H.; owned \$1,000.00 worth of real estate; his wife, Lavina, was born in Pa. as were their 3 eldest children: Louisa, age 21; Mary J., 17; and Adaline, 13; the youngest child, Abraham M., age 6, was born in Ill.
- FOSTER: Burrow M. (1845-1920) appears on an 1880 county census and was living in Bethel Twp.; members of the household included: Mary R., age 34; and Samuel M., 14.
- FRISBIE: William W. and Joseph Louis appear on the 1880 county census and was living in the Wm. Frisbie household in Bethel Twp.; members of the family included: William, age 44; Margaret, 28; Phelemon, 9; William W., 5; Joseph L., 3; and Robert Ingersoll, 1.
- FUGATE: John W. (1817-1898), son of Martin and Nancy B. (Hobbs) Fugate; b. Russel Co., Va., Apr 13, 1817; moved with parents to Monroe Co., Indiana, thence to this county in 1832; bought a 160 acre farm in section 30, Bethel Twp.; married Sep 19, 1839, in this county, to Ophelia C. Monk; had 3 children: Samuel N., Martin V., and Mary R.; both sons were killed in battle during the Civil War; after his first wife's death in 1847, Mr. Fugate then married on Dec 28, 1865, to Nancy A. Toland, native of Ohio.
- John Fugate a veteran of the Mormon War; served from this county; Sam'l H., son of John, enlisted in Bethel Twp., on Aug 11, 1862; died of wounds at Resaco, Ga. on May 17, 1864. The other son of John's, Martin V., enlisted at the same time as his brother, Sam'l, and was killed at Chickamauga on Sep 20, 1863.
- John appears on the 1840 county tax list as #642; he owned \$100.00 worth of horses, \$12.00 cattle, and \$96.00 in other property; taxes were \$1.04. John W. appears on the 1880 county census report and was living in Bethel Twp.; members of the family included: John W., age 63; Nancy A., 42; Nancy B., 90; George W., 29; Elmyra, 26; Clara L., 7; Etta L., 4; and Bessie D., 2.
- Martin Fugate, father of John W., appears as #641, on the 1840 county tax list; he owned \$200.00 worth of horses, \$90.00 cattle, \$10.00 clocks & watches, and \$179.00 in other property; taxes were \$2.40.
- HALL: Richard (1821-1880); b. Lexington, Ky.; was a resident of Ill. for 44 years; enlisted as a private on Dec 13, 1861 at Tennessee, Ill.; mustered out on Jan 21, 1865; married Mary Patton in this county on Jun 30, 1842; died of pneumonia at age 58y 8m 14d, in Lamoine Twp.

Amos (1821-1853) appears on the 1850 federal census for Eden Twp., Schuyler Co., Ill.; he was born in Ohio in 1821; his wife, Eliza A., born in 1822, in the state of Tenn.; their 3 children were born in Ill.; they were: Ann, age 7; Harriett, 5; and Abi, 1. Also living in the Amos Hendrickson household in 1850, was Otis P., a brother of Amos.

Amos married Eliza Ann Campbell in this county on Nov 24, 1842.

Otis P. (1828-1886); born in Ohio; in 1850 was living with a brother, Amos, in Schuyler County, Ill.; Otis was a blacksmith by trade, and in 1850, owned \$150.00 worth of real estate.

Sarah D. (1871-1918), wife of Fred. (Obit, in part, from The Macomb Journal, May 7, 1918): "Miss Sarah Oletha Serrot, daughter of Mr. and Mrs. J. T. Serrot, was born Dec 8, 1871, in Schuyler County, and departed this life May 3, 1918 at 6:30 p.m., in Lamoine township, being at the time of her death 46y 5m and 26d old..... united in marriage to Fred E. Hendrickson Oct 11, 1893, and to this union were born five children, Merle in training at Camp Dodge Iowa; Morris, Ruth, and Vera at home; Mary Elizabeth preceding her in death 15 years ago.....she leaves to mourn her loss, a father, mother, husband, four children, one brother, Charlie Serrot of Omaha, a sister Mrs. F. H. Hendrickson of Weldona, Colorado...."

HINES: The Daniel Hines (1848-1927) family appears on the 1880 county census report living in Bethel Twp.; members of the household included: Margaret E., 27; Perry, 7; Emma, 4; and Walter, 1.

HOLTON: William Sr. (1771-1857); b. in the state of Vt.; son of Joel and Bethiah (Farwell) Holton; Joel born in Northfield, Mass., Jul 10, 1738; Wm. came to this county about 1835.

William Sr. appears as #675 on the 1840 county tax list; owned \$15.00 worth of horses, \$36.00 cattle, \$10.00 clocks & watches, \$30.00 wagons, and \$50.00 in other property; taxes were \$ .71.

Olive (1772-1836); born in the state of Vt.; maiden name was Rockwell.

William Jr. (1804-1875); son of Wm. & Olive Holton; b. in Vermont; moved to this county, 1835; lived on section 30, Bethel Twp.; later lived in Lamoine Twp. Appears on the 1840 county tax list as #932; owned \$75.00 worth of horses, \$75.00 cattle, \$15.00 clocks and watches, \$79.00 in other property; taxes were \$1.22.

Betsey (1800-1841) wife of William Jr.; b. in the state of Vermont; maiden name was Mason; married in Vermont.

HOLTON: William, Jr. (1804-1875); had 6 children by his first wife; Wm., after death of Betsey in 1841, then married Maria Sophia Widdill; they had 2 children: John Wesley and Elizabeth Rachel (Mrs. Jacob P. Myers).

Henry and Rebecca also raised a nephew, James Allen Toland, b. Dec 6, 1871; he was a son of Henry's sister, who died shortly after James Toland was born. Henry A. and wife, Rebecca, appear on the 1880 county census and were living in Bethel Twp.; members of the household included the following children: Jeremiah, age 23; Catharine, 21; Emma, 19; David, 17; Amos, 15; and Isabel, 11.

Henry A. (Obit, in part, from The Macomb Journal, Jan 30, 1913): ".....one of the oldest settlers of McDonough county, died at his late home in Lamoine township Friday night of bronchial pneumonia, aged 83 years, 10 months and 9 days.....Deceased was born in Westminster, Vt., and came to this state in 1835, making the trip overland with his parents when but six years of age.....He located in Bethel township but soon after moved to the farm in Lamoine where he died...He was married in 1851 to Rebecca Scott, who died about 15 years ago.....He is survived by these children: James H., Kirksville, Mo.; Mrs. Mary Cavett, Colchester; Jeremiah, Colchester; Katherine Bodenhammer of Plymouth; Amos of Chicago; Belle Ruffner, Macomb; David of Lamoine. He leaves also two brothers--Reuben A. of Colchester and Lyman of Wiltonville, Nebr., and two sisters--Mrs. Elizabeth Myers of Colchester and Mrs. Bell Marvin of Norton, Kan."

William B. (1851-1852), son of Henry A. and Rebecca (Scott) Holton.

Charles E. (1830-1887), son of Wm. and Betsey (Mason) Holton; b. at Westminster, Vt., Sep 7, 1830; moved with parents to this co., 1835; md. Nov 12, 1867, to Etta McKinley; Chas. spent 11 years (1853-1864) in California; he and Etta had 2 children: Ida Blanche (1868) and Ada Ford (1872). Appears on the 1880 county census report; they were living in Bethel Twp.; members of household included: Charles, age 29; Etta M., 32; Ida B., 11; and Ada F., 9.

Ettie (1848-1885), wife of Chas. E.; b. in Ohio; moved with parents to this county in 1857, from Meigs Co., Ohio; Ettie was a school teacher in Schuyler county several years.

(1844-1906) (Obit, in part, from The Macomb By-Stander, Feb 9, 1906): "John Wesley Holton died Friday evening at his home on the Jerry Hickey farm, a mile south of Colchester, aged about 70 years. He had been a resident of this county for many years, much of the time of Lamoine township. He was a veteran of the Civil War and well known in the southwest part of the county."

Reuben Rockwood Holton; d. May 8, 1883; age 87y 11m 10d; farmer; b. Westminster, Vt.; in Ill. 35 yrs; d. Lamoine Twp. Reuben R. (1795-1883) and wife, Margaret A. (1803-1884) appear on the 1880 county census; they were living in Bethel township.

Margaret (1803-1884) (Obit, in part, from The Macomb Journal, Apr 10, 1884): "Margaret A. Holton was born in Vermont in 1803. She joined the M.E. Church in 1818. In 1832 she married Wm. Albee; he died in 1842. She then married Reuben R. Holton in 1847 and in 1849 they came to McDonough County where he died in 1883....."

David W. Holton died Jun 14, 1882; age 9d; b. & d. in Lamoine Twp.

HOOK: Nettie, (1866-1888) wife of W. M.; dau. of Thos. & Jerusha Ann (Burrress) Shoopman.

HOOTEN: W. H. (d. 1867); native of Ohio; settled in this county, 1836; lived in Lamoine Twp.

HUFF: William A. (1808-1868) appears on the 1850 federal census for Brooklyn Twp., Schuyler County, Ill.; he was born in N.C.; farmed, and owned \$1,000.00 worth of real estate; his wife, Betsey A., was born in Va.; all their children (listed on the 1850 census) were born in Ill.; they were: Martha, age 16; John C., 14; Mary, 12; Amanda, 11; Melissa, 8; Maria, 7; Francis M., 5; and Sarah, 2.

??Wm. Huff and family moved from Indiana to Brooklyn Twp., Schuyler Co., Ill., in 1832; lived on section 7.??

JARVIS: Garret J. D. (1835-1865), son of James & Permelia (Driscoll) Jarvis; James, b. Madison Co., Ky. in 1812; Permelia, native of Mercer Co., Ky.; James & Permelia married in Edgar Co., Ill. in 1832; lived in Hire Twp. till 1845; moved to Tennessee Twp.; Garret was a brother to: John M. (moved to Crowley, Kan.); Henry M. (Tenn. Twp.); James E. (Winfield, Kan.); Samuel M. (Kansas City); Joseph M. (d. in infancy); Nancy A. (d. in infancy); Isaac S. (d. 1846); William H. (d. Perryville, Ky., 1863). Garret J. D. enlisted Aug 13, 1862, at Tennessee, Ill.; promoted to Lt.; killed at Ft. Blakley, Ala.

Philena (1839-1883) (Death notice, in part, from The Macomb Journal Oct 25, 1883): "Mrs. Phelina Jarvis died at her home in Lamoine Twp. on Oct 8th, aged 44 years. Her husband was Garret J. D. Jarvis and he was killed at Fort Blakely near Mobil on Apr 9, 1865. She remained a widow until her death....."

KENNEDAY: John (1805-1871); b. in N.C.; moved to this county from Davison Co., N.C. in 1836; lived on section 26, Lamoine Twp.

Simeon M. (1835-1927); b. in N. C.; moved to this county at age 1 year with parents, John & Susannah Kenneday; md. in this county & farmed on section 35, Lamoine Twp.

Malinda (1837-1878), wife of Simeon M.; b. Adams Co., Ill.; d. of Bright's Disease in Lamoine Twp., this county.

George (1857-1877); died in Lamoine Twp.; cause of death was suicide.

LAWYER: George J. (1828-1913), son of William; George was born in Fayette Co., Ohio, Oct 24, 1828; Wm., native of Pa.; moved to Brown Co., Ill., in 1835; to this county in 1836; lived in Tennessee Twp.; Wm. moved to Appanoose Co., Iowa in 1856; then, to Wayne Co., Iowa where Mrs. Lawyer died; Wm. then moved to Union Co., Iowa and died there in 1883; George was a brother to: Elizabeth (Mrs. Hoagland, moved to Mo.); Dedmarius (Mrs. Wm. Breeden); Catharine (Mrs. Ethan Jarvis); John W. (moved to Washington Terr.); Sam'l; William, moved to Union Co., Iowa; and Susan. George married Nov, 1867, to Amanda C. Wear; they had 7 children: Sarah C. (Mrs. Geo. Huffman); Nancy E. (Mrs. James Mathews); William H.; David J.; Susan J.; Joseph E.; and George M.

Amanda C. (1832-1901), wife of George J.; daughter of Hugh and Sarah (Duncomb) Wear.

LITTLE: Lamech D. (1819-1895), son of Lamech & Elizabeth (Henderson) Little; b. in Md., Jan 16, 1819; moved with parents to Harrison Co. Ohio, 1825; Lamech, Jr. moved to this county in 1839; married either Dec 30, 1843 or Dec 31, 1840, to Francis Henderson; had 7 children: Catharine J., James, Eliza, Ann, Cyrus, and David. After the death of his first wife in 1851, Lamech married Margaret J. House; they adopted 2 children--Ellen and Lamech.

James Randolph (1843-1861), son of Lamech, Jr. & Francis (Henderson) Little; died of diphtheria.

MASON: Burow (1814-1888), born in Cook Co., East Tennessee, May 6, 1814; son of Adin & Mary (Warmact) Mason, natives of Va.; Burow moved to Bethel Twp., this county, 1836; married Dec 8, 1846, to Eveline Hendrickson; had 11 children: Adin P.; Jesse H.; Eliza J.; George W.; William B.; Benjamin B.; Samuel P.; Etta R.; Robert; Ruth Ann; and John.

Burow appears on the 1840 county tax list as #637; owned \$40.00 worth of horses, \$39.00 cattle, \$10.00 clocks and watches, \$15.00 cash loaned out, and \$62.00 in other property; taxes were \$.83.

Burow appears on the 1880 county census report; members of the household included: Evaline, age 52; George W., 23; Edmond W., 21; Benjamin B., 19; Samuel P., 17; and Etta, 13.

Jesse H. (b. 1853) appears on the 1880 county census as living with wife, Nancy E., age 21, in Bethel Twp.

Frances E. (b. 1866), wife of W. E.; daughter of John B. and Mary E. (Kirk) Davidson.

MATTHEWS: James E. (1844-1925) appears on the 1880 county census as living with his wife and son in Bethel Twp.; the family consisted of: Nancy E., age 24; and George N., 1.

MILL: Phoebe; d. Sep 27, 1881; age 77y; single; d. in Bethel Twp.

MONK: John (1808-1885); son of Malachi and Jemima (Jones) Monk; b. Hardin Co., Ky., Jan 6, 1808; moved with parents to Ind., in 1812; then moved with parents to this county in 1832; lived in Bethel Twp.; Malachi died in April 1840, and was buried on his farm in section 7, Bethel Twp.; Jemima died in Feb. 1859, and buried in this cemetery (NOTE: No stone located for her); John married in Ind., Jan 28, 1829, to Mahala Stroud; had the following children: Hester A., Thomas W.; Sam'l; Emily J.; William; twins--Simon & Mary; and Henry F.

Mahala (1810-1901), wife of John Monk; daughter of Thomas and Jane (Moore) Stroud.

John appears on the 1840 county tax list as #677; owned \$80.00 worth of horses; \$46.00 cattle; \$10.00 clocks & watches, and \$132.00 in other property; taxes were \$1.34. John and Mahala appear on the 1880 county census and were living in Bethel Twp.

John; (Death notice, in part, from The Macomb Journal, Jul 9, 1885): "John Monk, one of the oldest inhabitants of McDonough County, died at his residence in Bethel township last Friday. He was born in Hardin County, Ky. in 1808. When he was 4 years old, he moved with his parents to Indiana where he grew to manhood and married in 1829, to Mahala Strode. She survives him. In 1832, he came to Illinois with his father's family. They settled in Bethel township, section 7. He had also lived at Plymouth, Hancock County, for a time. He raised a large family."

Jemima, mother of John and widow of Malachi, appears on that 1840 tax list as #676; she owned no real estate and a total of \$233.00 worth of personal property; taxes were \$1.17.

MONTEE: Ina Isabelle (1874-1910), was the wife of Dr. Chas. Finney Montee, a Colchester physician. Ina and Dr. Montee were married in this county on Nov 18, 1897. Dr. Montee was a son of Frank M. and Mary E. (Purdum) Montee and was born in this county in 1870.

MORRIS: Simeon (1790-1862); moved to this county from N. Carolina in about 1836; son, Sam'l F., born Sep 15, 1816, also came to this county and lived in Lamoine Twp. (Another reference says Simeon moved in 1834 from Va. to the north part of Birmingham Twp., Schuyler Co.) Simeon appears as #927 on the 1840 county tax list; owned \$100.00 worth of horses, \$108.00 cattle, \$30.00 carriages, \$75.00 wagons, \$100.00 cash loaned out, and \$200.00 in other property; taxes were \$3.07.

Sarah (1815-1848); wife of Sam'l F.; Sam'l appears as #926 on the 1840 county tax list; owned \$60.00 worth of horses, \$46.00 cattle, and \$40.00 in other property; taxes were \$ .73.

James A. (1813-1884) appears on the federal census for Brooklyn Twp., Schuyler Co., Ill.; he was born in Tenn.; farmed, and owned \$500.00 worth of real estate; his wife, Unity, was born in Va. in 1814; all their children (Listed on the record) were born in Ill.; they were: Hannah, age 12; Nancy, 10; Elizabeth J., 8; Martin P., 6; Mary, 4; and John W., 2.

Mary E. (1861-1904), daughter of Solomon and Alpha (Baggett) Mullen; b. in this county; married Martin P. Mullen of Schuyler Co., Ill., Jan 8, 1884. Solomon died in Macomb in 1868; Alpha remarried, in about 1883, to James A. Logan, of Schuyler Co.

OSBORN: The Robert Osborn (d. at age 58y) family appears on the 1880 county census and was living in Bethel Twp.; members of the household included: Robert, age 32; Elizabeth J., 30; William E., 8; Isaac M., 7; Susannah, 4; Emmasiah F., 6; and Brice W., 1 month.

POMEROY: Orlando (1837-1895) and family appears on the 1880 county census report as living in Bethel Twp.; members of the household included: Orlando, age 39; Mary E., 27; Nellie L., 10; Cornelia, 6; William W., 3; and Homer F., 1 month.

PURDUM: (NOTE: Name also spelled as PURDHAM) Samuel (1801-1878), native of Md; moved to Ill., 1838/1840; lived in Schuyler Co., Ill. and Bethel Twp.; married Rebecca Brown, a native of Va. and Ohio. Appears as #679 on the 1840 county tax list; owned no real estate; \$120.00 worth of horses, \$35.00 cattle, \$60.00 wagons, and \$95.00 worth of other property; taxes were \$1.55.

Appears on the 1850 federal census for Brooklyn Twp., Schuyler Co., Ill.; he was born in Maryland; he was a merchant and owned \$1200.00 worth of real estate; his children, as listed on this report, were all born in Ohio; they were: Martha J., age 18; Abraham, 17; Miskieh, 13; Samuel, 12; and James, 10.

Rebecca (Brown) Purdum, wife of Samuel, died in 1842; Samuel then married Elizabeth Tullis, native of Ross Co., Ohio; she was a daughter of John Tullis of Ohio. Samuel was a son of Walter Purdum. Samuel moved to this county from Hamilton Co., Ind; operated a saw mill and lived on section 25, Lamoine.

Samuel (1837-1918) son of Sam'l and Rebecca (Brown) Purdum; b. at Hamilton Co., Ind, Oct 29, 1837; moved to this county with parents in 1838; mother died when he was 4 years old; raised by his father and step-mother; attended schools in this county and Schuyler Co.; worked as a carpenter; md. Feb 25, 1866, to Cornelia J. Rigsby, native of Schuyler Co.; they had the following children: Hattie; Ella (Mrs. Edward Hendrickson); Theodore (d. in infancy); Myrtle (Mrs. Anderson Ward); Catherine (Mrs. E. J. Blodgett); Josie Ann

Olive D. (1865-1865), daughter of James & Sarah E. (Foster) Purdum; Sarah born in Schuyler Co., Ill.; md. Feb 19, 1860; lived on section 30, Bethel. James, a son of Sam'l and Rebecca Purdum, was a carpenter.

Abraham (d. 1863), son of Sam'l and Rebecca Purdum; enlisted in Scotland Twp., Aug 6, 1862; served as a private with Co C, 84th Ill Inf.; d. at a Nashville, Tenn. hospital.

Samuel (1837-1918), son of Sam'l and Rebecca Purdum; enlisted at Tenn. and commissioned 2nd Lt., Mar 28, 1865; mustered out Dec 8, 1865.

RIGSBEE: John E. (1810-1880) appears on the 1850 federal census for Brooklyn Twp., Schuyler Co., Ill.; he was born in N.C.; farmed and owned \$1,000.00 worth of real estate; his wife, Martha, was born in Va.; also living in household in 1850, was his mother, Leanna, born in N.C.; children shown in the Rigsbee household in 1850 were: Sarah, age 13; Cornelia, 11; Calvin, 9; George W., 7; Ann, 5; and Eliza, 2. All the children were born in Ill.

John E. Rigsbee and family came from Ind. with the Huff's ---- settled in north part of Brooklyn Twp.; named the area "Guinea Prairie."

ROBINSON: Arthur L. (1909-1910) (Obit, in part, from The Macomb Journal, Aug 31, 1910): "Arthur L. Robinson was born in Lamoine Twp. Jan 17, 1909, and died Aug 29, 1910, aged 1 year, 7 months, and 12 days. He was very patient during his illness until his death, which was caused by spinal meningitis. He leaves to mourn his departure, his father and mother, Mr. Perry W. and Mrs. Julia M. Robinson....."

SCOTT: John (1804-1875), b. in Ireland; moved to this country in about 1825; lived in Ohio and married there to Mary Hendrickson.

Richard (1846-1864), son of John & Mary (Hendrickson) Scott; enlisted in Bethel Twp., Feb 25, 1864; served as a private in Co A 78th Ill Inf.; died of wounds in Georgia.

The 1860 federal census for Bethel Twp. indicates the following individuals residing in the John Scott household: John (age 62, b. Ireland); Mary (age 51, b. Maryland); John (age 22, b. Ohio); Isabella (age 20, b. Ohio); Amos (age 18, b. Ill); James (age 16, b. Ill.); Richard (age 14, b. Ill.); Joshua (age 12, b. Ill.); and Mary C. Cavett (age 14, b. Ill.).

John Scott married Mary Duncan in this county on Nov 7, 1833.

Solomon (1836-1918); b. in Ohio; moved to this county in 1840 from Carroll Co., Ohio; farmed on section 36, Lamoine Twp.

SERROT: John (1849-1931) and Mary (1852-1932); parents of Sarah D. Hendrickson; lived in Schuyler County, Ill.

SHELTON: Sarah (d. 1851), wife of John A.; John appears as #920 on the 1840 county tax list; owned \$150.00 worth of horses, \$100.00 cattle, \$10.00 clocks & watches, \$100.00 wagons, and \$140.00 in other property; taxes were \$2.50.

SHOOPMAN: Thomas F. (1811-1906); b. in E. Tennessee; son of Jacob and Polly (Owens) Shoopman, natives of Va.; moved with parents to Hopkinsville, Ky. in 1829; Jacob died there in December, 1829; remainder of the family moved to Morgan Co., Ill. and stayed there till 1833, when they moved to this county; Polly died in this co., 1840; Thomas married Patience Smedly, native of Tenn., and they had 10 children: Elizabeth, Nancy J., Jacob, John S., Mary, Susan, Sarah, Catherine, Martha and Hannah. After the death of Patience in 1864, Thos. married Mrs. Jerusha Ann Burress in 1865; Thos. and Jerusha had two children: Nettie Caroline (Mrs. W. M. Hook; she died at age 21 years) and Albert. Jerusha had by her first husband, 5 children: Edna J., Elmira A., William F., Toliver D., and Joseph T.

Thomas F. appears on the 1840 county tax list as #640; he owned no real estate; had \$30.00 worth of horses, \$54.00 cattle, and \$60.00 in other property; taxes were \$ .72. Also appearing on this list, as #646, was Jacob Shoopman; and as #626, was George W. Shoopman. (NOTE: All surnames appeared as "SHOCTMAN" on this list.)

Thomas F. appears on the 1880 county census; he and other members of the Shoopman family were living in Bethel Twp.; the household included: Thomas, age 68; Ruth A., 47; Genetta C., 12; and Albert, 11.

SPIVA: The James Spiva family appears on the 1850 county census as follows: James, age 40, farmer, b. Tenn.; Rebecca, age 39, b. Ky.; children, as follows, all b. in Ill.: Amanda, 16; Louisa, 14; Mary, 11; Able, 8; Ann M., 7; Cynthia, 3; Sarah, 10 mos. Also in the family was a Mr. Combs, age 19, farmer, b. Ill.

STUMP: Charles F. (1878-1961) was a son of Isaac and Sarah E. and a brother to John E. Other members of this family are buried at the Dunkard Cemetery.

TOLAND: William, Sr. (d. 1865); b. in Pa.; married Jane Hendrickson in Ohio; moved to this county, 1840; lived in Bethel Twp.

Sarah E. (1842-1886), wife of Wm., Jr.; b. in Ill.; maiden name was Welborn; married Wm. Toland, Jun 25, 1868; dau. Nellie, b. Feb 25, 1880; William served 2 years with the 78th & 148th Ill Inf. during the Civil war; mustered out in Sep., 1865.

Nettie Davis (1869-1921) (Obit, in part, from The Macomb Journal, Mar 17, 1921): "Nettie Davis, daughter of John and Sarah Davis, was born in Brooklyn township, Schuyler county, Jan 29, 1869, where she grew to womanhood. Nov 27, 1889, she was united in marriage to Alva C. Toland, and to this union five sons were born, three of which are deceased.....greater part of her life was spent in Brooklyn and Birmingham townships, the past twelve years being spent in Macomb and vicinity.....Sunday afternoon she became seriously ill and was at once removed to the Marietta Phelps hospital. Monday morning she underwent a operation, but few hopes were entertained for her recovery. She grew steadily weaker until at 9:10 Tuesday evening she passed away.....Death was due to strangulated hernia. She leaves to mourn her passing, two brothers, Arthur of Birmingham, Ill., and Oliver of Macomb, her husband and sons, Teslie, at home, and Otha and wife and granddaughter, also of Macomb. Three sons, Gilbert, Ernest, and John having gone before her.....services held at the home, 433 North Monroe St....."

Alva C. (1861-1929) was a son of James and Juliett A. Toland; James was born in 1828; Juliett, in 1838; Alva was a brother to Solomon H. (b. 1870).

**TWADDLE:** William (1809-1879), b. in Ohio; from a family of 15 children, 5 of whom were born blind; moved to this county from Jefferson Co., Ohio in 1844; served as justice of peace for over 30 years; married Hannah Hooten and had the following children: John W., William H., Marsena A., James, Mary Ann (Mrs. W. W. Huff), Mahlon, George, Minerva E. (Mrs. Wm. Lawyer), David, Jacob, and a daughter that died in infancy in Ohio.

George W. (1845-1887) (Obit, in part, from The Macomb Journal, Sep 22, 1887): "George W. Twaddle died Sunday in Bethel township. He was born on the farm where he died on Aug 28, 1845, the son of Wm. and Hannah (Hooten) Twaddle, early residents of this county who had come here from Ohio. When his parents died, George became the owner of the homestead. He was married the first time on Jul 19, 1868, to Cynthia, daughter of Alonzo and Minerva Hatch. She died the following January and he then married Miss Philema Stookey, who with five children, survives. His last marriage was on Sep 28, 1872. He was a justice of the peace in his township and was the brother of Wm. H. Twaddle, a Macomb attorney...." George and Philema has the following children: Clinton Earl, Maber, Perry, Ottie P. and Otto B. George appears on the 1880 county census and was living in Bethel Twp. with his family as follows: Philena D., age 27; Maber, 7; and Perry, 3.

VAN WINKLE: James M. (d. 1900) appears on the 1880 county census as living with his family in Bethel Twp.; members of the household included: James, age 33; Hannah L., 31; Elizabeth F., 11; Drewlilla, 8; Thomas O., 4; and Patience M., 4.

WEAR: Hugh, Sr. (1790-1873); b. in Washington Co., Tenn.; moved to Lamoine Twp., this county, in 1835 from Monroe Co., Tenn.; wife was the former Sarah Duncombe. Appears as #696 on the 1840 county tax list; owned \$50.00 worth of horses, \$98.00 cattle, \$10.00 clocks and watches, \$5.00 carts, \$40.00 cash on loan, and \$205.00 in other property; total taxes were \$2.04.

Maria, Clarissa J., and Cordelia were daughters of Joseph D. and Mary B. (Downs) Wear; Joseph, a son of Hugh and Sarah (Duncombe) Wear; moved with his parents to this county in about 1835; J. D. and Mary Wear had 10 children; lived in Lamoine Twp.

WELBORN: Thomas J. (1815-1893) and family appear on the 1880 county census; they were living in Bethel Twp.; members of the household included: Thomas J., age 65; Minerva, 54; Elizabeth C., 27; Marcena W., 24; Isaac J., 22; Linzy, 20; and Charles, 17.

WILSON: Charles (1784-1847) appears as #672 on the 1840 county tax list; he owned \$25.00 worth of horses, \$105.00 cattle, \$10.00 clocks and watches, \$50.00 carriages, and \$100.00 in other property; taxes were \$1.45.

## Dunkard Cemetery

Location: Bethel township; SE $\frac{1}{4}$ , Section 18. Three miles southwest of Fandon.

Remarks: This cemetery was established in connection with the Dunkard church which was located nearby for a number of years. In 1883, the German Baptist Brethren organized in this vicinity and built a church near the southeast corner of section 18 Bethel township. As far as is known at this time, the only other Dunkard, or German Baptist church in the county was located in Mound township. The current condition of the cemetery is good; when surveyed for this report in 1975, the grounds were completely fenced and the area indicated regular and dedicated maintenance. All stones were standing upright; most were completely readable. Several small, metal markers (supplied by mortuaries) marked individual graves.

## Old Plymouth Cemetery

Location: Lamoine township; SW $\frac{1}{4}$ , Section 30; about 2 miles north-east of Plymouth.

Remarks: This old cemetery, unused since the 1860's, lies about a half-mile west of Illinois Route 61 on privately owned property. Due to the many years of neglect, nearly all traces of this graveyard are now gone. The information listed below, obtained during a survey made in March of 1975, is far from complete because of the difficulties encountered in locating stones and/or their original locations. There are a number of field-stones, which at one time contained names, dates, etc. but are now totally unreadable. An estimated two dozen bases for stones were located (in addition to the ones listed below), however, no markers were found for the bases. The probability exists that some of those originally interred here were later moved to other cemeteries, but no records are known to prove or disprove that idea. Nearly all the memorials found during this registration were located under several inches of leaves and sod. A History of McDonough County, printed in 1885, makes mention of this graveyard as follows (pg. 662): "A burying ground is also located on section 30, on the farm of Dr. King, and contains about one acre. The first burial was a small child of Isaac Smith, about the year 1841. For a number of years it was used for interment purposes by the town of Plymouth. It is not in use at all, at present."

SMITH: NOTE: Local history accounts state that the first burial in this cemetery was that of a child of Isaac Smith's in 1841; no stone was located for this individual.

Jul 26, 1819, in Hopkins Co., Ky.; son of John, native of Va.; John, St. d. in 1825; John Jr. moved with his widowed mother to Va. in 1825; then to Sangamon Co., Ill., 1829; to this county, 1832; lived with a brother in Industry Twp. for a short time; in 1834, moved to Lamoine Twp. and started farming on section 30; then moved to section 20 in 1854; md. Mar 28, 1839, to Miss Davenport, a native of N. Y.; they had 10 children: Harriet, Morris C., Caroline, Henry, Paris, Leroy, Isaac G., Albert M., Romine, and John W.

John was accompanied to Lamoine Twp. with a brother, Byrd Smith; Byrd d. in 1880, in Plymouth, Ill.

John, father of Leroy, appears on the 1840 tax list as #885; he owned 40 acres in the SE $\frac{1}{4}$  of section 30; also \$18.00 worth of cattle, and \$10.00 in other property; taxes were \$ .94.

Byrd, brother of John, owned 80 acres in the NE $\frac{1}{4}$  of section 31, Lamoine Twp.; also \$140.00 worth of personal property.

Isaac G. (1807-1853); b. in Va., a son of John & Nancy (Garret) Smith; moved with parents to Ky. in about 1814; moved to Springfield, Ill., 1829; to this county, 1834, and settled on section 31, Lamoine Twp.; md. in 1834, to Jane Garret; cause of Mr. Smith's death was described as "a white swelling". I. G. Smith served as county commissioner during the 1840's and was a justice of the peace for several years.

Isaac G. appears on the 1840 county tax list as #883; he owned 120 acres in sections 30 and 31, Lamoine Twp.; also \$100.00 worth horses, \$43.00 cattle, \$10.00 clocks & watches, \$30.00 carriages, and \$110.00 in other property; residence was located in the west  $\frac{1}{2}$  of the NE $\frac{1}{4}$  of section 31, Lamoine Twp.

Isaac G. Smith appears on the 1850 county census as follows: Isaac G., age 42, farmer, b. Va.; Jane, age 37, b. Va.; all the following children b. in Ill.; Samuel R., 16; Jonetta, 14; Nancy, 12; Lensey, 13; John H., 2; and an infant, aged 6 mos.

SWISEGOOD: Sarah E. J.; daughter of Wm. & Margaret; both parents were natives of N.C.; Sarah was a sister to Mary (b. 1853), Bell (b. 1856), & George (b. 1859). All the children were born in Ill. The family lived in Lamoine township in the 1860's.

WHITTINGTON: James A., father of Emily, Eva, and Emma, was born in Ill. in about 1831; his wife, Angeline, was a native of Ohio, b. there in about 1835. Another daughter, Sarah J., was born in Ill. in 1858.

Polly Friend & Noah Jones - Jul 4, 1832

Ludica Friend & Peyton Herring - date uncertain, probably about 1833

Also in Schuyler County .....John and James Friend owned land together apparently as single men in the early 1830's (Sec 23 T 2 - R 3). Joseph and Elender Friend also owned land in this same section. Abel Friend owned land in section 15 T 2 - R 2... ..earliest date 1829.

The estate settlement of Strangeman Friend is in Schuyler county; he died Aug 23, 1834. Cornelius Swain, a relative, was the administrator. The relationship was not stated, just that he was related and the widow chose not to serve. In other information learned... there was a terrible cholera epidemic in July and August 1834 in Schuyler County so this may have been the cause of his death. In the 1830 Census of Morgan Co., Ill., Strangeman Friend is a young man with small children.

John Friend ran on Democratic ticket in 1854 for McDonough County Coroner.....defeated.

John Friend served as a Private, from McDonough County, during the "Mormon War" in 1846.
