Vandalism is responsible for the destruction of many grave stones. Countless markers have been partially or totally destroyed. Stones have fallen, broken, and become mixed with soil and debris.

Preface

Within the boundaries of McDonough County, Illinois are more than a hundred cemeteries and gravesites ranging in size from a single burial site to the expansive Oakwood Cemetery at Macomb. Within these cemeteries are the remains of an estimated 40,000 individuals who have died since the first settler arrived here over 150 years ago. Graves of countless others are scattered over the countryside of McDonough County; but, exact sites of many of these resting places are no longer known for various reasons. During the early days of this county, there were obviously no central burial grounds; thus, a pioneer family having the misfortune of losing one of its members placed the deceased in a grave on a family homestead and erected a makeshift marker. A number of these family burial grounds later became public cemeteries, however, many of the grave sites soon became "lost". Crude wooden markers or a hand engraved stone soon succumbed to the elements and were never replaced; scores of families moved further west after staying in this area only a short time and the gravesites of their loved ones shortly became insignificant mounds of earth; a number of families passing through this vicinity suffered individual losses. A prime example of the latter is contained in a history of Bethel Township. In 1830, four children of an emigrant family died while enroute through McDonough County. They were buried near their places of death which occurred about two miles southwest of Fandon. All traces of those graves have long been gone. During the summer of 1834, a widow lady died at her home in northern Tennessee Township. Her coffin of dressed walnut lumber was built by a local cabinet maker and she was buried in the timber near her home. Within a few years, no evidence remained to indicate the presence of her final resting place. A family who created an excellent farm from the prairies a few miles north of Macomb, maintained a fenced family burial site for several years. This cemetery contained the graves of about 12 former family members. During the early 1900's, the farm changed ownership. Shortly thereafter, the new owner removed all the stones, took down the fence, and this graveyard became part of a cornfield. These are only three of the countless incidents involving the total disappearance of burial sites. At this time, it is impossible to determine the locations of hundreds of individual's graves in this county.

Vandalism is responsible for the destruction of many grave stones. Countless markers have been partially or totally destroyed. Inscriptions have been obliterated by shotgun blasts, stones have been broken into dozens of pieces, and some markers have been entirely removed from their original locations.

While weather-wear and vandalism accounts for most of the destruction of individual tombstones, neglect is directly responsible for the eventual deterioration of graveyards. Several local cemeteries have had no protective fencing for a number of years and the grounds have become grazing land for livestock. Groundhogs and other burrowing animals have undermined large portions of various cemeteries. Some areas are nearly invisible because of massive growths of weeds and brush. Stones have fallen, broken, and become completely covered with soil and debris.

The overall conditions of our county cemeteries is a pathetic case. While some grounds are well maintained, or at least partially kept-up by various families, many have been totally forgotten. This situation is appalling and should never have come about. Apparently, lack of time, expense, and most of all regard has brought about the present-day poor conditions of many of our rural cemeteries.

Genealogical notes accompanying the various cemetery listings were prepared from a wide variety of sources including: Local area history books and atlases; newspaper files; county, state, and federal archives; family histories. These notes were collected at random from readily available sources and little, or no attempts were made to search for material for more complete genealogies. These notes are presented only for the purposes of identification and/or clarification.

Every attempt has been made to present complete and accurate information. Readers will find errors and omissions. Others will not agree with portions of my findings; however, no information contained herein is based solely on assumption or guesswork. It must be remembered that this information has been prepared for use only as a tool for further research and that nothing must be taken as final and absolute.

The larger cemeteries contained in these volumes are accompanied by grave location charts. These charts in no way are intended to represent any professionally prepared plat or survey that may exist. Their preparation and presentation are solely for general location purposes.

When copying inscriptions from grave markers, it is sometimes impossible to read some portions of the engraving. Names, dates, ages, etc. that were found to be unclear or totally missing are indicated by the use of question marks or dashes, i.e., SPICER, James T., infant son of ?J.B. & S.J.?; d. ----; age ----. The letters or numbers enclosed in parenthesis following the inscription, indicate general location as indicated on the accompanying chart.

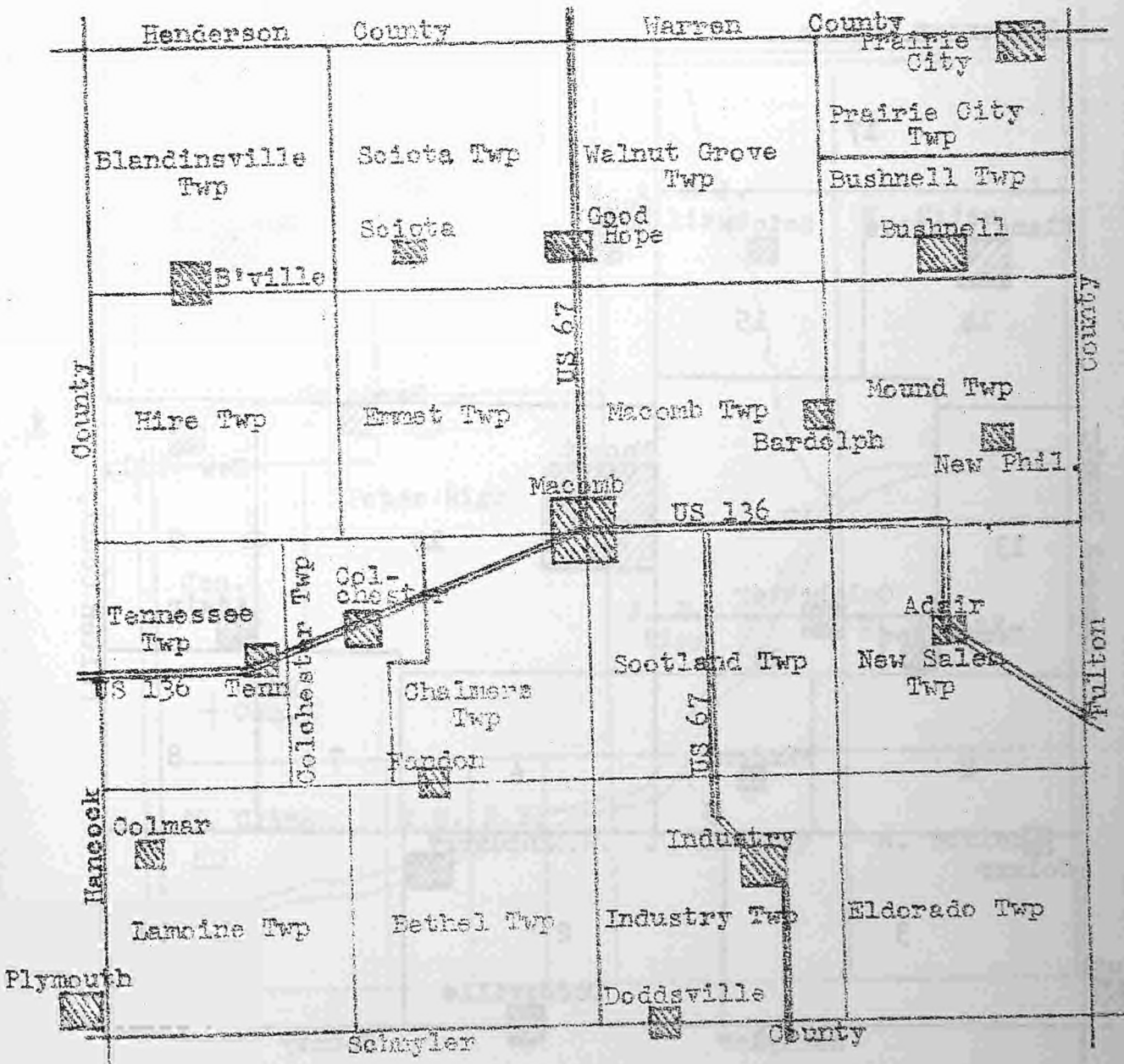

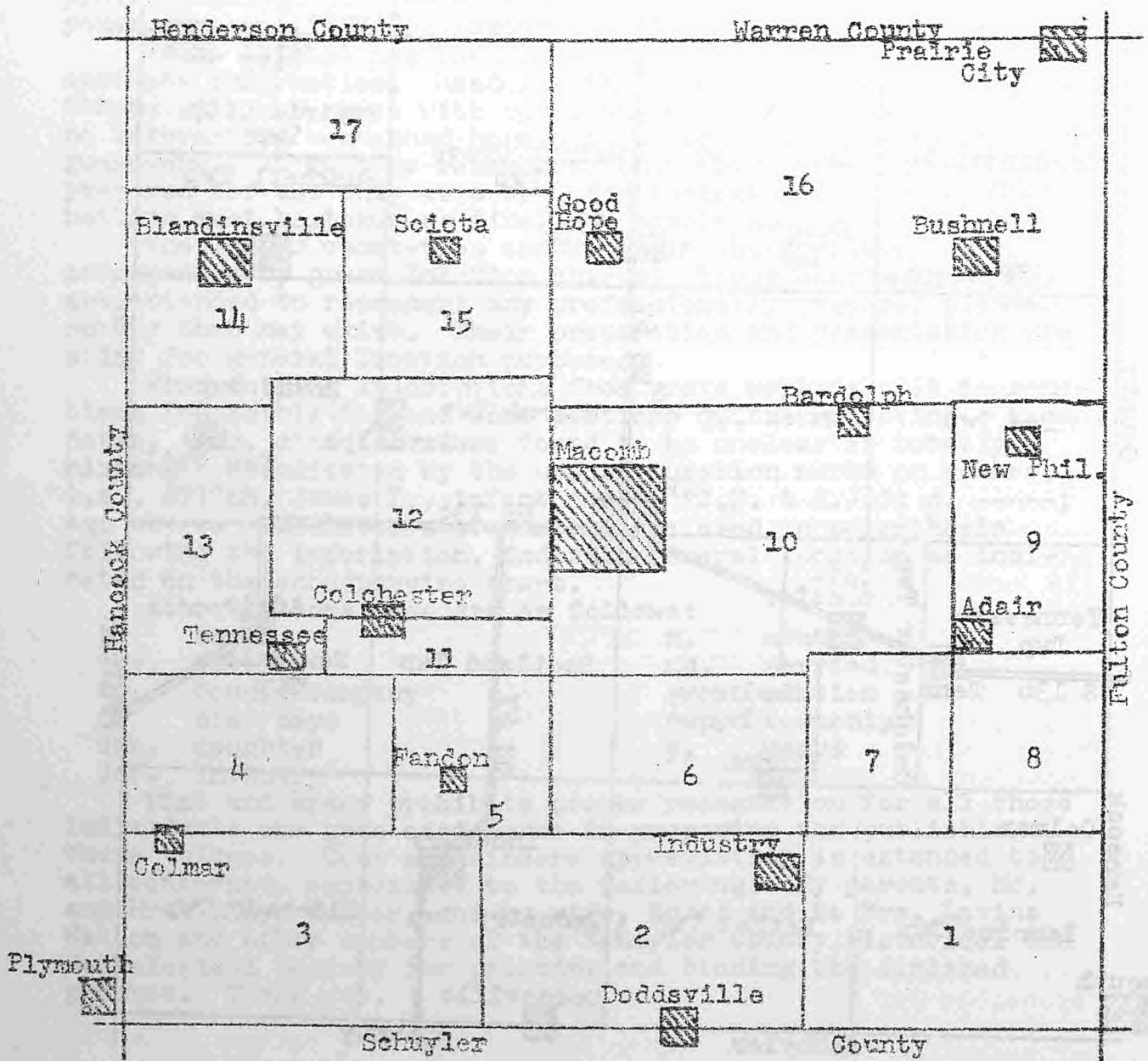

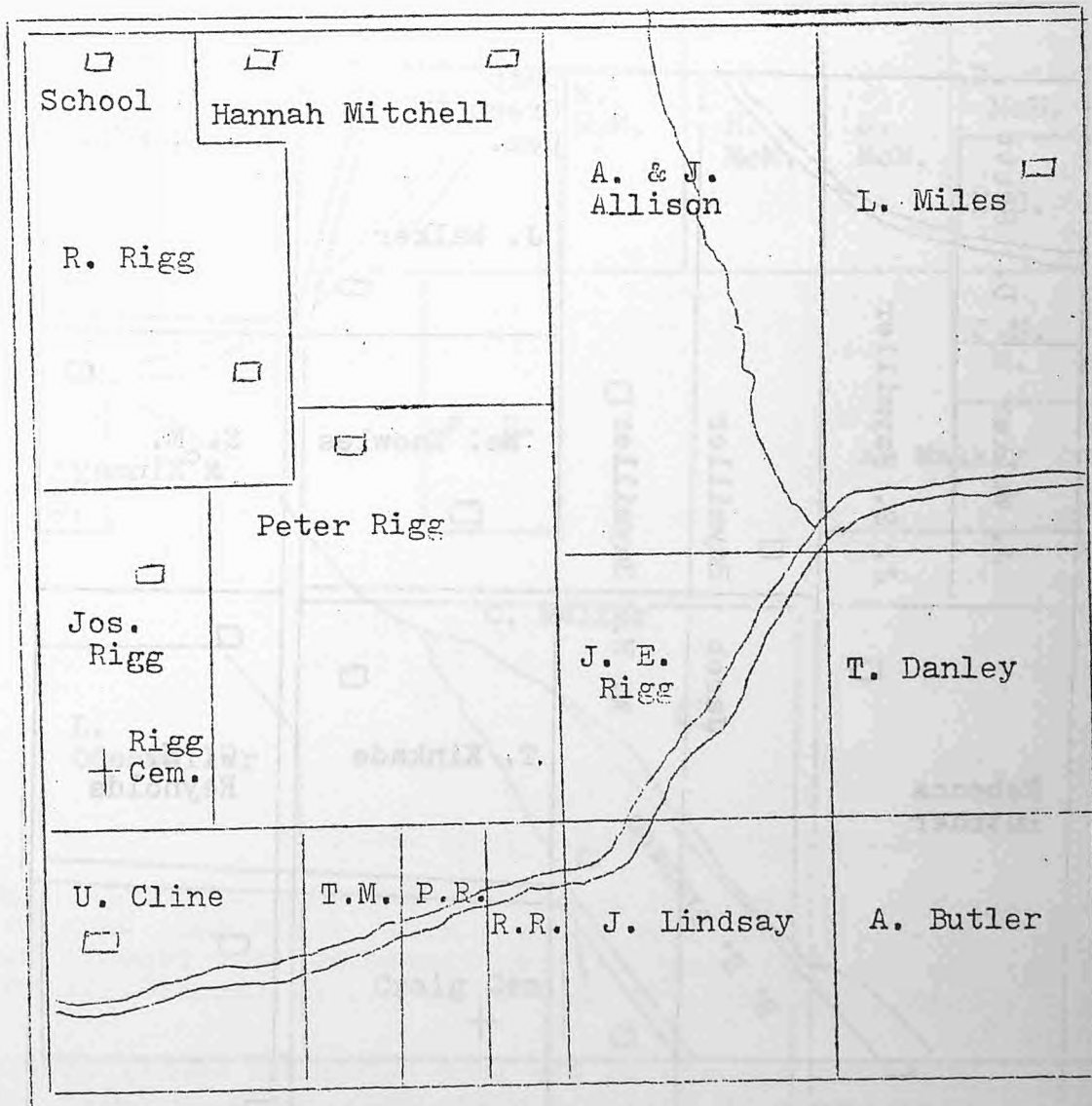


Areas covered by volumes I - XVII

Bethel Township, T4N R3W; 1871



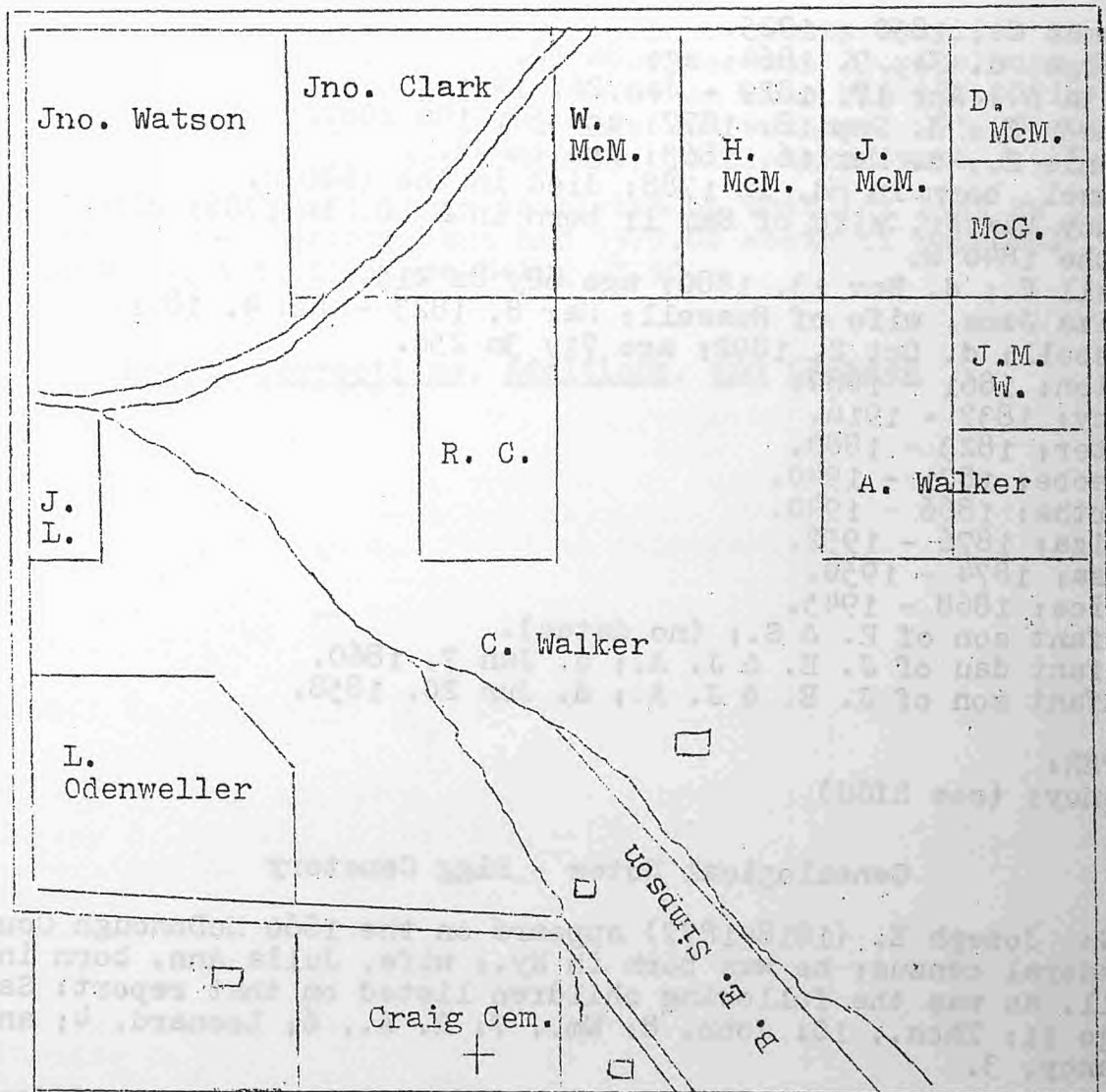

Rigg Cemetery

Location: Bethel Township; SW $\frac{1}{4}$, Section 1. Six miles south of Macomb.

Remarks: This family burial ground is situated on privately owned property and is about 200 yards from a public road. The stones were found to be in relatively good condition during this 1975 registration, however, the grounds are covered with a heavy growth of weeds and grass. The area is well fenced on all sides.

Genealogical Notes - Rigg Cemetery

RIGG: Joseph E. (1818-1877) appears on the 1860 McDonough County federal census; he was born in Ky.; wife, Julia Ann, born in Ill. as was the following children listed on that report: Sam'l, age 11; Thos., 10; John, 8; Wm., 7; R. A., 6; Leonard, 4; and Nancy, 3.

Peter (1823-1880) appears on the 1860 McDonough County federal census; he was born in Ky.; his wife, Lucy, born in Ill.; their daughter, Olive, was also born in Ill. in 1860.

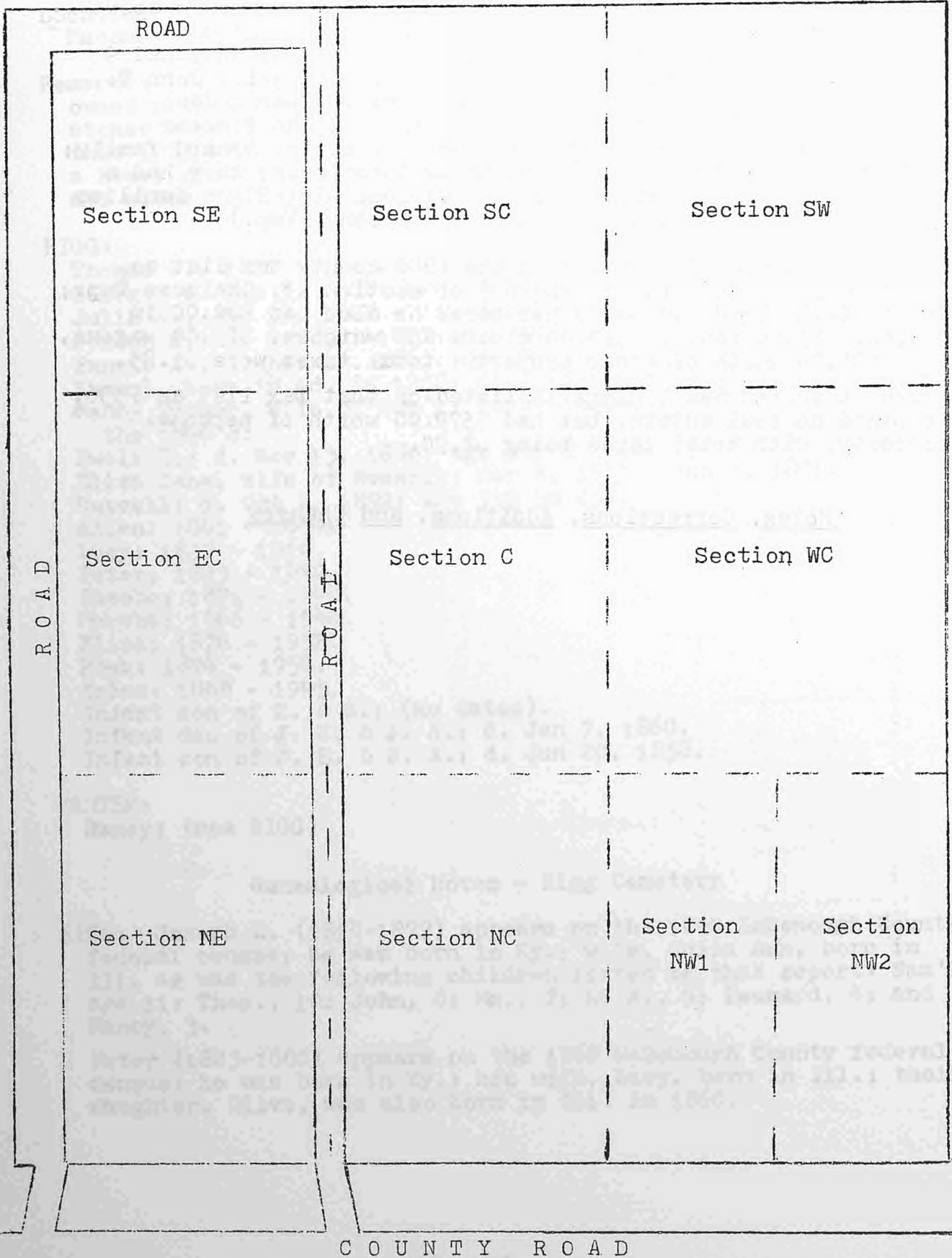
RIGG: Russell (1821-1892); son of Sam'l & Nancy (Vawter) Rigg, born in Greenup Co., Ky., Jun 7, 1821; moved with his parents to Sangamon Co., in Ill. in 1828; then to this county in about 1835; lived on section 1, Bethel Twp.; Russell first md. in this county on Nov 2, 1845 to "Sally" Jane Venard; they had 9 children including the following: Mary E., James L., John T., Samuel B., William D., Andrew W., and Anna B. Sarah Jane (Venard) Rigg died in 1870; she was buried at the Pioneer Cemetery in Bethel Twp. with other members of the Venard family; on Feb 2, 1871, Russell Rigg md. Eliza Jane Lucas; they had a son, George W. (Several members of various Rigg-Riggs families are buried at Archer-Bethel Cemetery in Bethel Twp.)

RIGGS/RIGG: Samuel T. appears on the 1840 county tax list as #393; he owned 20 acres in the NW¹/₄ of section 23, Chalmers Twp.; value of the land was \$4.00 per acre; he also had \$80.00 in horses, \$25.00 cattle, \$10.00 clocks and watches, \$75.00 wagons, and \$100.00 worth of other property; total taxes were \$1.85.

NOTE: A second Sam'l Riggs is listed on that tax list as #536; he owned no real estate, but had \$579.00 worth of personal property, with total taxes being \$2.90.

CAMP CREEK CEMETERY
Industry Township
NE $\frac{1}{4}$, Section 5



Camp Creek Cemetery

Location: Industry Township, T4N-R2E; NE $\frac{1}{4}$, Section 5. Five miles south of Macomb on County Route 4 (Candy Lane) to "T" intersection, then one mile southeast.

Remarks: Camp Creek Presbyterian, originally located about a half mile east of this cemetery, was established in about 1832, however, members congregated in private homes, barns, or in the open until the original church building was completed in 1834-44. This building was used until about 1861, when a new, larger one was erected about a mile northeast of the original site. The first settlers to establish permanent homes in this area arrived in the late 1820's and the first burial in the Camp Creek settlement area was reportedly that of a migrant who died here in about 1831. He was said to have been buried a short ways west of the present site of the cemetery but was later moved to the fenced grounds. Camp Creek cemetery is still being used and is regularly maintained; the grounds are fenced and the overall appearance is good. Many of the older stones are weather-worn to the point of unreadability; most of the monuments are standing erect. During this survey, made in early 1975, the earliest-dated stone located carried an 1837 date. This cemetery has been surveyed and recorded in the McDonough County court house. The original and first two additions have an unknown number of lots; the third addition has 32 lots and the fourth addition, 73 lots. The cemetery board of trustees maintains a record of lot owners. Note: The attached diagram of the grounds has not been prepared to indicate specific lots or blocks; the various sections shown and referred to are only for general orientation and location purposes.

Genealogical Notes - Camp Creek Cemetery

ADKISSON: Thomas (1800 - 1857); the Industry congregation of the Cumberland Presbyterian Church was organized at his home in Nov. 1843. In 1832, Mr. Adkisson and his family were living in Morgan Co. and had visited in this county with hopes of settling in Walnut Grove township; however, they later moved to Industry township. Thomas appears on the 1840 county tax list as #447; he owned 320 acres in sections 16 & 17, Industry Twp.; residence was in the SE $\frac{1}{4}$ of section 17; he also owned \$200.00 worth of horses, \$150.00 cattle, \$10.00 clocks and watches, \$60.00 wagons, and \$275.00 in other property; taxes were \$10.68. Thomas md. Sarah W. Moore this county on Feb. 22, 1835 (2nd marriage).

(Camp Creek Cen)

ADKISSON: Joseph Newton (1832-1903) was born in this county; son of Thos. and Margaret (Gibson) Adkisson, who came to this county in 1831. Margaret died on Aug 8, 1834. Joseph married in 1856 to Cassa Ann Harding, a daughter of Aaron Harding, a native of Ky. The Adkissons had 7 children: William F., moved to Neb.; Clara C. (Mrs. Geo. Shirk); Mary Margaret; John H. (?); George E.; Thomas M.; and Aaron Arthur. J. N. Adkisson was a school director and road commissioner.

James H. Adkisson married Malinda Janes in this county on Dec 24, 1844.

ALLISON: John (1851-1893), son of John & Maria (Provine) Allison; born in Schotland Twp.; married Nov 10, 1874, to Anna M. Munson; lived in Walnut Grove Twp.; had 2 children: Bertha Eudora and Mabel Maria.

A number of Allison's are noted on the 1840 county tax list; they included: Thomas (#389; no real estate; \$371.00 in personal property); Andrew ("on Troubleson Creek"; #391; no real estate; \$55.00 worth of horses; no other personal property); William (#397; owned 320 acres in section 24, Chalmers Twp.; also had \$765.00 worth of personal property); Harman (#398; no real estate; \$15.00 in personal property); James (#401; no real estate; \$200.00 in personal property); John (#532; owned 480 acres of land in Scotland and Industry Twps.; residence was on the NE $\frac{1}{2}$ of section 31, Scotland Twp.; he also owned \$970.00 in personal property, with total taxes being \$17.65). All the above Allison's were listed as residing in the south half of the county in 1840.

ANDREWS: John M. (1794-1881), born in England; son of William & Sarah (Williams) Andrews; md. Ann Biddlecomb in England; had 9 children, including: Charles, Thomas, William, James, Henry. John b. Essex England; d. Jun 28, 1881; age 86y-10m-4d; resident of Ill. 24 yrs.

Ann (1799-1870), wife of John M.; daughter of Thomas & Mary (Locky) Biddlecomb; born in England; came to this county in about 1851.

Charles (1825-1917), son of John & Ann Andrews; born in Somersetshire, England; he and his brother, Henry, moved to Philadelphia, Pa. in 1850; then came to this county in 1851.

Henry (1829-1902), son of John & Ann Andrews; moved to this county in 1851; farmed in Chalmers Twp.; never married; died in Scotland Twp. at the home of his brother-in-law, Joseph Bown.

James (1832-1903), son of John & Ann Andrews; born in Somersetshire, England; md. Rosanna Bown July 1854 a native of England; settled in Scotland Twp.; lived there till 1859; moved to Chalmers Twp.; farmed on Section 26, Chalmers; had children, including: John T., James A., Mary E., Anne E., Jessie A., Rhoda E.

ANSTINE: John (1788-1860); born in Pa.; moved to Ohio in 1840; to this county in about 1856; lived in Industry Twp. Married to Mary Heindle in Pa. A son, Simon, was born in York Co., Pa. in 1821; he later farmed in Industry Twp.

BEAVER: Frank was a son of I. N. & Rana (Hess) Beaver.

I. N., father of Frank (1868-1869), was a native of Ohio and moved to this county from that state in 1864; the family lived in the town of Industry where Mr. Beaver owned a drug store.

BECK: James (1794-1875) appears on the 1840 county tax list as #454; he owned 160 acres in the SE $\frac{1}{4}$ section 18, Industry Twp.; also had \$80.00 worth of horses, \$50.00 cattle, and \$102.00 in other property; taxes were \$4.36. NOTE: Beside Mr. Beck's name in the tax list is the following notation: "Land (taxes) paid by Morton".

BINNIE: Andrew (1805-1855), born in Falkirk, Scotland, Mar 9, 1805; son of Robert, also a native of Scotland; Andrew married in Scotland to Agnes Waddill; had 7 children, including: Robert & John, twins; Andrew, James, and Annie (Mrs. John F. Watson); the family moved to America in 1847 or 1849 and lived in Astoria, Fulton Co, Ill. for a few months; then moved to Scotland Twp.

Agnes (1814-1879), wife of Andrew; born in Scotland Oct 14, 1813/14.

Andrew (1844-1905) born in Forfarshire, Scotland, son of Andrew and Agnes (Waddill) Binnie, natives of Scotland; the family moved to America in 1847; lived a short time at Astoria, Ill.; then moved to Scotland Twp.; this county; Andrew, Jr. married Sarah Herndon; she later moved to Macomb.

BLACK: William H. (1816-1896), born in Pa.; moved to this county from Pa. in 1840; farmed on section 31, Industry Twp.

BLAZER: John (1814-1903); came to this county in 1836 from his native state of Pa.; farmed on section 8, Industry Twp. Appears on the 1850 federal census as living in Rushville, Ill.; his occupation was listed as a broommaker; he was born in 1814 in Pa.; his wife, Mary, born in 1814, in Ohio.

Mary Ann (1820-1898) (Obit, in part, from The Macomb By-Stander, Mar 23, 1898): "Mrs. Mary A., wife of John Blazer, died at her late home in Macomb on South Randolph street last Saturday evening after a lengthened illness of heart disease. She was in her seventy-eighth year.....Deceased's maiden name was Phillips, and she was born near East Liverpool, Ohio, Sep 20, 1820. In Feb, 1857, she was united in marriage with John M. Blazer, who had been a resident of Camp Creek neighborhood for several years, and they returned to that vicinity soon after their marriage. This was their home till about eight years ago, when they moved to this city where they have since resided. Mrs. Blazer leaves, besides her aged husband, two step-sons, James M. of Chicago, and Charles H. of East Liverpool, O., and two sisters, one in Iowa City and one in Pennsylvania."

(Camp Creek Cem)

BLISS: James T., father of Jessie A. (1865-1867), was the minister at Doddsville for a short time; in 1865, he was named as pastor of the Ebenezer Church in Scotland township; he was replaced in 1868, by Rev. Mullans. James later moved to Macomb and lived on E. Carroll Street. A son, William H., died at that home in February, 1897, at age 56 years.

BRIDGES: Thomas B. (1842-1863) enlisted in the army at Industry on Aug 7, 1862; served as a private with Co I, 78th Ill Inf.; discharged on Aug 24, 1863, because of a disability.

BUCHANAN: George & Martha (Robinson) Buchanan were the parents of: Rebecca (Mrs. Heath); Mary (Mrs. Lewis Linn); Martha; Minerva (Mrs. Ritchie); Jane (Mrs. Green); Clelland; and Robert. Daughter Mary md. Lewis Linn in this county on Sep 22, 1861; she died Mar 28, 1879, at age 49y 6m 3d; born in Park Co., Indiana; originally buried at Camp Creek, however, later removed to Oakwood Cemetery in Macomb.

BULLOCK: Thomas; d. Jan 7, 1881; age 86y 10m 24d; married; b. Ireland; resident of Ill. 45yrs.; d. Bethel Twp.

BUTCHER: James (1814-1886); born in Ohio; moved to this county, 1861. (Obit, in part, from The Macomb Journal, Mar 25, 1886): "James Butcher died at his residence in Industry on Mar 17, aged 72 years. He was born in Homer, Licking Co., Ohio on Mar 4, 1814 and was married to Miss Levina Sillen in Oct, 1839; they came to Indiana in 1840 and to Industry in 1860. He was the father of 6 children: 4 boys and 2 girls, all of whom are married....."

Levina (1820-1900) wife of James; born in Ohio; maiden name, Scillen.

Gertie (1905) (Obit, in part, from The Macomb Daily By-Stander, Apr 15, 1905): "Gertrude, the 3-months-old daughter of Mr. & Mrs. Ross Butcher, died Friday evening, at their home in Chalmers township. Pneumonia, from which the little patient had been suffering from for the past six weeks, caused the death..... Besides its parents the child leaves a twin sister."

John M. (1840-1911) enlisted in the army at Macomb on Aug 8, 1862; served as a private with Co H, 2nd Ill Cav.; re-enlisted after a year; mustered out on Jun 11, 1865.

Adaline (1842-1876), wife of Bowman R. Butcher; Mr. Butcher served during the Civil War in the same unit as John M.; both discharged from the army in 1865.

CAMPBELL: James Harvey (1856-1859), was a son of Nelson M. and Martha H. (Clark) Campbell; Mr. Campbell came to this county in 1835 and lived near Camp Creek; he was born in Cook Co., Tenn. in 1814. Other children born to Mr. & Mrs. Campbell were Nancy (Mrs. George Patrick); Ross R., and John W. Mrs. Campbell died in February, 1905, and was buried at Oakwood in Macomb.

CARROLL: Daniel (1799-1872) was on the first town board of the village of Industry, established in 1867, at the time of its incorporation.

CLARK: John (1794-1876), born in Scotland, Nov 19, 1794; emigrated to America in 1817; lived in Washington Co., Va. and in Indiana before coming to Illinois in 1834; lived in Morgan Co. a year, then came to this county; farmed on Section 27, Scotland Twp.; moved to Macomb in 1863; married in Baltimore, Md. on Sep 29, 1817, to Nancy Clark; she was also a native of Scotland and came to America on the same ship as John; they had children including: John (died at age 3 years in Va.); Robert; Jane (Mrs. Alex. McMillen); Martha H. (Mrs. Nelson Campbell); Nancy; James; and Samuel K. After Nancy Clark in 1861, Mr. Clark married second to Mrs. Jane Provine, the widow of Alexander Provine.

John was a son of James Clark, who died in Scotland at the age of 70.

James (1825-1903), eldest son of John & Nancy Clark; born in Washington Co., Va; came to this county with parents in 1835; began farming on section 28, Scotland Twp. in 1850; married on Apr 7, 1853, to Margaret A. Watson; had 3 children: Belle (Mrs. John S. Patrick); William H.; and Jane. James lived in Cass Co. for a year then came to this county and lived in Scotland Twp.

Margaret (1826-1901), wife of James; daughter of James or David Watson; native of Scotland.

William Harvey (1866-1934), son of James & Margaret Ann (Watson) Clark; born in Scotland Twp. Oct 10, 1866; married on Mar 15, 1894, to Elizabeth McMillan.

Samuel K. (1832-1890) farmed on section 27, Scotland Twp.; born in Va. and moved to this county in 1835 from Morgan Co., Ill.

Robert, son of John & Nancy Clark, died on Oct 22, 1860, at age 33 years; he was survived by his widow and one child.

CLAYTON: Mrs. R. E. (Death notice from The Macomb Journal, May 4, 1882): "Mrs. Rebecca Clayton died at her residence in Industry on April 28th, aged 43 years. The funeral was Saturday at C. P. Church with burial in the Camp Creek Cemetery."

COKER: Wayne E. (1914-1922); d. Nov 18, 1922; age 7y 11m 18d; son of George W. & Martha Jane (Moore) Coker; died in Bethel Twp. (Obit, in part, from the Macomb Daily Journal, Nov 18, 1922): "Wayne Everet, little seven year old son of Mr. & Mrs. George W. Coker of five miles southwest of Industry died at his home this morning after an illness of four days with diptheria. Because of the family being quarantined there will be a private funeral.....Besides the parents, the following brothers and sisters survive: Orville of Industry; Arlo Vernon, Clifford, David, Mrs. George Stoneking, Mrs. Samuel Peel, and Mrs. George Frakes all of Birmingham."

COCKER: George W. (1818-1901); farmed on section 17, Industry Twp.; born in W. Tenn.; moved to this county in 1832 from Tenn.; married Elizabeth Kennedy, this county, Nov 30, 1848.

CREEL: Durham M. (1821-1902), son of Durham & Mary (Smith) Creel, natives of Ky.; attended school in Cherry Grove seminary, Knox Co., Ill.; married in this county, Oct 17, 1849, to Mary E. Standard; she died in 1855; they had 2 children; he remarried Jul 4, 1857 to Mary C. Adkisson; began practice of medicine in Industry in about 1858; served as an Assistant Surgeon with the 78th Ill Inf. from Mar 24, 1864 to Jun 7, 1865. Parents and several other members of the Creel family buried at Hamilton Cemetery, Walnut Grove Twp.

CULLEN: Mary Ellen; d. Mar 8, 1922; age 26y 9m 18d; wife of Frank H. Cullen; b. May 20, 1895, in Scotland Twp.; dau of Wm. & Elizabeth (McMillan) Clark, both natives of Ill.; Mrs. Cullen was resident of Scotland Twp. & died at the Holmes Hospital in Macomb.

CURTIS: Edward E. (1842-1864) enlisted in the army at Macomb on Aug 8, 1862; killed at Sabine, La. on Apr 8, 1864; served as a private with the 2nd Ill Cav.

W. C. (1840-1884) (Death notice from The Macomb Journal, May 22, 1884): "William Curtis, a former citizen of McDonough County, died at Girard, Kansas where he had lived for about 12-14 years. He was a son of Israel Curtis, deceased, and a brother of George Curtis, well-known in this city and Mrs. J. E. Venard. He was born in 1840 and was aged 44 years. He is survived by a wife, Livia, and 5 children (1 son is of age)."

Olive; (Obit, in part, from The Macomb Journal, Dec. 21, 1882): "Mrs. Olive Curtis died at her residence in Macomb on Dec. 21st, aged 59 years. She was born in Reading, near Boston, Mass., where she grew to womanhood. Her maiden name was Flint. She married Israel Curtis of Andover when she was 21 years old and they immediately moved to Kentucky where they lived for a few years. Then they moved to Randolph Co., Ill., near Chester. They then moved to Nauvoo at the time of the Mormon migration. Thence to Plymouth, Hancock Co., and to McDonough Co. 30 years ago. Her husband died 6 years ago. She was the mother of 10 children, 6 of whom are living. One son was killed in the Civil War. Her son, William, resides at Girard, Kansas....."

ELLIS: John Frederick (1857-1935), born in Fulton Co., Ill. May 28, 1857; son of James and Margaret (Walker) Ellis, natives of Ireland; John was the youngest of 8 children; moved with parents to this county in 1860; married Apr 5, 1881, to Mary E. Andrews; had 5 children: Mettie (Mrs. A. J. Hamilton); Anna (Mrs. A. W. Ford); Luther; Flora; and James Roscoe.

ELSTON: Elsie Louise; d. Apr 15, 1922; age 15d; dau of Mr. & Mrs. Louis Elston; mother's maiden name was Osborne.

(Camp Creek Cem)

FERSTER: James (1846-1869), son of **D. R. Ferster**; second son of a family of several children including: Ada M., Effie C., William R., Clements, Luther, Samuel C., and Henry. The Ferster family later lived in the Macomb area.

FIKE: The following death notice, in part, appeared in the Sept. 5th, 1894, edition of the Macomb By-Stander: "Miss Elizabeth Fike died at the home of her father, Jackson Fike, last Saturday and was buried Sunday at the Camp Creek Cemetery....."

NOTE: No stone was located for this individual.

FREAM: The following death notice appeared in The Macomb Journal July 14, 1881: "Mrs. Fream died at the residence of her son-in-law, Clarence Spear, in Scotland Twp. on July 8th, aged 69 years. Born in Sommerset Co., Pa. where she grew up and married; to this county 25 years ago; buried Saturday in the Camp Creek Cemetery. Daughter is Mrs. Simeon Ritcher of Emmet Twp. **NOTE:** No stone located for this individual.

GIBSON: John (1791-1853) appears on the 1840 county tax list as #448; as there were three John Gibson's on this list, this Mr. Gibson was identified on the report as "wagon maker"; he owned 160 acres, the NE $\frac{1}{4}$ of section 16, Industry Twp.; also had \$217.00 cattle, \$10.00 clocks and watches, \$125.00 wagons, and \$406.00 in other property; total taxes were \$8.97. John enlisted in the army at Industry on Aug 12, 1862; served as a private with Co I 78th Ill Inf.; discharged due to a disability on Apr. 6, 1863 (John, Jr.); Children of John & Rachel (Taylor) Gibson were: Alfred (1819-1898); Ellen G. ((1821-1914); Mrs. Wm. Peak); Benjamin (1825-1847); William (1827-1847); Columbus C. (1832-1910); Samuel T. (1837-1864); and twins, John (1840-1923) and Rachel (1840-1855).

John, Jr.; court records indicate he died in 1923 and was buried at Camp Creek. During the early 1900's, John, Jr. and his family were living in Oneida, Ill. John, Jr. married Frances Tuggle in this county. Mrs. Gibson was a daughter of John & Mary Tuggle of Industry Twp.

Samuel T.; d. 1864; enlisted in the army at Industry on Aug 11, 1862; died in a military prison on Aug 24, 1864; buried in the Andersonville Prison cemetery---grave No. 4,201.

GREGG: Harvey T. (1828-1875); first enlisted at Paririe City, Ill. on Apr 18, 1862; commissioned a Captain; resigned from service on Sep 23, 1862; entered service again at Industry as a 1st Lt. on Oct 4, 1865; served with Co C 151st Ill Inf. till being discharged on Jun 20, 1866.

HENDERSON: Samuel G. (1812-1893) farmed on section 29, Scotland Twp; born in Ky.; came to this county in 1838 from Iowa.

Henry H.; according to Illinois VA records, Mr. Henderson was commissioned a 2nd Lt. at Scotland Twp. on Dec 16, 1865, and served with Co D 28th Ill Inf. till his discharge on Mar 15, 1866.

HIATT: Celestie E. (1851-1889), wife of Williamson S.; married Dec 12, 1871; maiden name was Hess; had 4 children: Bessie B., Sarah J., Willis Enos, and Arthur H. Mr. Hiatt was a son of Isaac and Sarah (Manlove) Hiatt; that family moved from N. Carolina to Schuyler Co., Ill. in 1838; then to Industry Twp. in about 1867; W. S. operated a drug store in the town of Industry.

HILL: James enlisted in the army at Macomb on Jul 22, 1862 and was discharged because of a disability a few months later; served as a private with Co C 84th Ill Inf.

JANES: Walter (1787-1852) was born in Ky.; moved to Industry Twp. in 1834; farmed on section 7; wife, Adra, born in Ky.; her maiden name was Crook. Walter appears on the 1840 county tax list as #448; he owned 160 acres in the NW $\frac{1}{4}$ of section 20, Industry Twp.; he also had \$150.00 worth of horses, \$100.00 cattle, \$60.00 wagons, and \$240.00 in other property; taxes were \$4.35.

Children of Walter and Adra (Crook) Janes were: Polly; Elizabeth; Jane (Mrs. Samuel Dixon), Lucinda (Mrs. John C. Vawter), Jesse, Malinda (Mrs. James H. Adkisson), Emily (Mrs. Alfred Gibson), Maria (Mrs. Wm. L. Danley), John, Thomas, and Bryant.

Nancy J. (d. 1893), wife of John; maiden name was Vanter; married to John Janes in 1854; had several children including: William B., Allen, Thomas S., Paris J., Amy B., Addie E., George J., Edgar, Paulina, and Eliza A.

George W. (1862-1903) (Obit, in part, from The Macomb Times, May 28, 1903): "George W. Janes died at his home in Emmet Twp. last evening at 8:45 o'clock, aged 40 years, 8 months and 7 days. Death was caused by paralysis from which he has suffered for a couple of years.....Deceased has lived in this county all his life, being a son of John Janes of Industry. He was united in marriage with Clara Bradford, who with three children, survive. He also leaves two brothers, Ed and Paris, and four sisters, Mrs. Etna Kinkade, Mrs. Chas. McGaughey, and Misses Addie and Anna."

JONES: Margaret (1827-1852); maiden name was Campbell; married Westley Jones in this county on Jan 11, 1848.

KINKADE: Hugh (1784-1867) appears on the 1840 county tax list as #402; he owned 80 acres in the SE $\frac{1}{4}$ of section 17, Industry Twp.; also had \$100.00 worth of horses and no other personal property; taxes were \$2.10.

John P. (1810-1851), born in Scott Co., Ky.; moved to Morgan Co., Ill. in 1830; then to this county in 1832; lived on section 5, Industry Twp.; married to Eliza D. McClure while living in Morgan Co.; children included a son, William, born in 1839. John appears on the 1840 county tax list as #452; he owned 320 acres of land in Industry and Scotland Twps.; residence was on section 5, Industry Twp.; he also had \$125.00 worth of horses, \$60.00 wagons, \$75.00 cash loaned out, and \$255.00 in other property; total taxes were \$12.53.

KINKADE: Eliza, widow of John, remarried in 1859 to Josiah Kirkpatrick.

John H. (d. 1863) enlisted in the army at Macomb on Aug 8, 1862; served as a private with Co H 2nd Ill Cav.; killed at Carrollton, La., Aug 23, 1863.

James T.; born in this county; farmed on Section 5, Industry Twp.

KIRKPATRICK: Joseph L. (1799-1869) born in Georgia; married Matilda Sims; Joseph was a son of Thomas & Mary (Lane) Kirkpatrick, native of Georgia; the family moved to Indiana territory in the early 1800's; then, in 1825, moved to Morgan Co., Ill.; Thos. & Mary died in that county; Joseph became a Methodist preacher; lived in Morgan Co., then moved to this county.

Matilda (1804-1877), wife of Rev. Joseph Lane Kirkpatrick; dt. of Mr. & Mrs. James Sims, natives of S. Carolina; Matilda & Joseph had several children, including two sons, Asbury and William B. who served in the army during the Civil War. Matilda died at the home of her son, John, in 1877.

John Lane (1841-1909), born in Morgan Co., Ill.; son of Joseph L. and Matilda (Sims) Kirkpatrick; John was the 7th child of 11 born to his parents; in June, 1860, John had his left arm amputated after being wounded by a gun shot; he and Mary F. Munson were married on Sep 15, 1868; they had the following children: Catherine M. (Mrs. H.C.D. Osborn); George Nelvin; and James Garfield.

Mary F. Munson (1846-1910), wife of John Lane Kirkpatrick; born in Rushville, Ill.; daughter of C.P. & Katherine Munson.

KNIGHT: S. C., father of Nancy (d. 1856), farmed on section 4, Scotland Twp.; he was born in Maine and moved here from that state in 1846.

KNOWLES: Robertson B. (1839-1915), a son of William and Lucinda (Robertson) Knowles; William was born in Washington, D.C.; moved to this county in 1838; Robertson was one of 8 children; William died in Macomb in 1875; Lucinda also died in Macomb, in 1877; R. B. served for 3 years during the Civil War; on Sep 19, 1865 he married Sarah Nunn, a native of Ky.; they had 7 children: Charles N., Etta E., Mary A., William L., Rebecca L., Dora M., and Gilbert. Mr. Knowles was the superintendent of the county poor farm for a number of years. Robertson B. enlisted in the army at Macomb on Aug 8, 1862; re-enlisted as a veteran after a year's service; mustered out on Jun 11, 1865.

LEACH: Jeremiah W. (1821-1888) owned an agriculture implement business in Industry during the 1870's and '80's.

LEIGHTY: Mary E. (1850-1886) (Death notice, in part, from The Macomb Journal, Aug 5, 1886): "Mrs. Mary E. Leighty died July 31st and was buried August 1st with her infant baby in the Camp Creek Cemetery. She was born in Uniontown, Pa., 1847. Her parents settled in Industry, this state. She was a member of C. P. Church.

(Camp Creek Cem)

LINDSEY: Jonah (1835-1905); son of James Lindsey; married Sarah J. Cochran; a son, Albert, later operated a Macomb grocery.

LITTLESON: James (1823-1874) farmed on section 10, Scotland Twp.; he was born in Scotland and came here in 1854.

LUCAS: William W. (1844-1886) (OBIT, in part, from The Macomb Journal, Jan 28, 1886): "William Lucas died at his home in Bethel Twp. last Thursday aged about 43 years. His wife is a daughter of Wm. Rush of this city. The deceased was the eldest son of Joseph Lucas, a resident in the southern part of the county. His brother is J. Albert Lucas of Potter Co., Dakota."

Joseph Lucas married Jane Campbell, this county, on Sept 27, 1842.

MC CLELLAN: George Everett; a son of William G. & Eleanor E. (Nunn) McClellan; William, a son of James & Abigail (Cornwell) McClellan. (See below) Other children of William & Abigail were: Charles L., Frank G., Dorothy B. (Mrs. C.D. Laughlin), and Donald S.

James (1797-1881); born in York Co., Pa.; married Abigail Cornwell; lived in Washington Co., Pa.; James was a carpenter; the family moved to Preston Co., Va.; then to Ill. in about 1853. James was a son of Robert & Nancy (O'Connor) McClellan, natives of Scotland and Ireland. (Death notice, in part, from The Macomb Journal, Jul 21, 1881): "James McClellan died in Macomb on July 21st aged 84 years. Born in Washington Co., Pa. and came to this county in 1853; his wife died some 6 years ago; Mr. McClellan died at the residence of his son, J. C....."

Abigail (1803-1855), wife of James; daughter of Price and Annie Cornwell.

MC CLURE: John W. (Death notice, in part, from The Macomb Journal, Jul 26, 1883): "John McClure died July 24th at Colchester. He was born in Chalmers Twp. and was the son of the late Sam'l McClure and a brother to Hugh McClure now living. He was unmarried and aged 40 years....."

MC CUTCHEON: Robert (1826-1917), born in Port Patrick, Scotland; son of Patrick & Margaret (Crawford) McCutcheon; Robert, the 2nd of a family of 4 children; he moved to America at age 21 years and worked in Pittsburg, Pa. for 5 years; moved to this county in about 1856; farmed in Chalmers Twp.; first married in Ireland, in 1846, to Elizabeth McMillan; they had 2 children: William and Elizabeth (Mrs. Chas. Magers); second married to Elizabeth Knox, a native of Pa.; they had 8 children including: Christiana (Mrs. Wm. Kaiser); Margaret (Mrs. Chas. Eddington); Robert; and Mrs. John Atkinson); Robert's second wife died in 1872; in Nov. 1873, Mr. McCutcheon married Margaret Kennedy, a native of Ireland; They had 8 children: Catherine (Mrs. F. Whalen); Alice; Charles; Lucy (Mrs. Pennington); Mable; Grace; Agnes; and Harry.

MC GAUGHEY: John G. (1808-1891), a son of James & Nancy (Grier) McGaughey; James died in Pa. in 1848; Nancy died in Industry Twp., this county, in 1852. John G. was born in Adams Co., Pa. Dec 9, 1808; learned the trade of blacksmithing; moved to Dodds-ville, Ill. in 1844; later farmed in Industry Twp/; married Jun 18, 1835, in Pa. to Hester Walker; had a number of children including: James G., Mary A., Andrew W., Mary J., Nancy, Hugh, John, William, Robert, and C. W.; the latter two died in infancy. Hester died in 1874, and Mr. McGaughey remarried in 1875, to Mrs. Susan M. Ellis. Farmed on section 9, Industry Twp.; John also lived in Putnam Co., Ind. before moving to Illinois.

In 1860 the following children were living in the household of John & Hetty McGaughey: James, age 24, b. in Pa.; Andrew, 20, b. Ind.; Mary, 17, b. Ind.; Nancy, 14, b. Ill.; Hugh, 13, b. Ill.; John, 10, b. Ill.; and Robert, 4, b. Ill; also Wm. Walker, age 20, was living with them in Industry Twp.

MC KAMY: Sam'l Walker (1818-1875) moved to this county from his native state of Tenn. in 1834; farmed on section 5, Industry Twp.

William C. (1810-1897), brother of Sam'l, moved to this county from Tenn. in 1834; farmed on section 4, Industry Twp.; was a son of John & Jane P. (Walker) McKamy; moved to this state with parents; lived in Industry Twp.; became a preacher in the 1830's; married Nov 1, 1842, to Octavia Robertson; had the following children: Julia, John, James R., George, Lucy, Cooper, and Elizabeth.

William appears on the 1840 county tax list as #438; he owned no real estate; had \$350.00 worth of horses, \$100.00 cattle, \$20.00 clocks and watches, \$50.00 wagons and \$485.00 in other property; taxes were \$5.03. William was born in Roane Co., Pa.

Octavia (1818-1904), wife of William C.; born in Adair Co., Ky.; daughter of Louis Robertson.

James R. (1849-1923), son of W. C. & Octavia McKamy; born in this county Oct 24, 1849; farmed in Industry Twp.; later moved to Macomb and lived on S. McArthur St.; married Nov 2, 1887, to Flora M. Baymiller, a native of this county. (Obit, in part, from The Macomb Daily Journal, Feb 19, 1923): "J.R. McKamy died at his late residence, 404 S. McArthur Street, Macomb, at 2:30 yesterday afternoon of an infection of the liver, aged 73 years, 3 months and 25 days..... James R. McKamy was born on the McKamy farm in Industry township, Oct 25, 1849, a son of Rev. & Mrs. W. C. McKamy, both well known residents of the county back in pioneer days. There he grew to manhood and took up farming which occupation he followed all his life until he retired from active work about twenty years ago and moved to this city, which has since been his home. "Doc" McKamy, as he was familiarly known, was a man of firm convictions.....He was united in marriage to Flora Baymiller, who survives. No children were born to this union. He is survived by two brothers, George and W. C., both of Macomb. One brother, John, is deceased. He leaves also two sisters--Mrs. W.D. Williams and Mrs. Elizabeth Martin, both of Macomb."

MC KAMY: (sometimes spelled MC KAMLEY) Mary Elizabeth; d. Apr 6, 1922; age 38y 6m 11d; wife of Sam'l W. McKamy; b. Sep 25, 1883 in Bethel Twp.; dau of Mr. & Mrs. W. O. Clark; mother, maiden name Walters, born in Ky.; father from Pa.; Mrs. McKamy died at Holmes Hospital in Macomb.

MC MILLAN: James A. (1859-1861) son of Alexander & Jane (Clarke) McMillan; Mr. & Mrs. McMillan married in this county on Sep 11, 1849.

John (1794-1864); born in Scotland; son of Duncan McMillan; married Margaret Watson, daughter of Hugh Watson, a native of Scotland; moved his family to America in 1843; lived in the Cincinnati, Ohio area about 5 years; then moved to Scotland Twp., this county; John & Margaret had 8 children: 5 boys and 3 girls.

William (1828-1910); born in County Down, Ireland, Feb 18, 1828; son of William & Elizabeth (Patterson) McMillan; the family moved to America in the 1830's and lived near Pittsburg, Pa.; Wm. came to this county in 1851/52; farmed in Chalmers Twp.; and also on section 27, Scotland Twp.; later moved to Macomb and lived at 537 S. Lafayette St.; married on Oct 16, 1851 to Elizabeth Stoops, a native of Ireland; had 4 children: Mary Jane (Mrs. Hendricks); Henry; Elizabeth Ann; and John Albert.

Duncan (1824-1901) moved here about same time as William; farmed on section 27, Scotland Twp.; married Jane Watson in this county on Oct. 19, 1849.

Infant male; d. Aug 11, 1879; age 3d; b. & d. near Pennington Point.

MC NAIR: Robert (1822-1912); eldest born of 9 children born to Robert & Jeannette (Smith) McNair; born in Argyleshire, Scotland; came to America in about 1839; lived in Ohio till 1851; then moved to this county; Robert never married.

Samuel (1836-1905), brother of Robert; born in Scotland; never married.

Robert (1785-1861); born in Scotland; son of Archibald McNair; married Jeannette Smith; had 9 children; moved to America in 1839; lived in Ohio; came to this county in 1851.

Janet (1795-1881), wife of Robert, Sr.; daughter of Robert Smith, a native of Scotland. (Death notice, in part, from The Macomb Journal, Jul 21, 1881): "Mrs. Janet McNair died at her home in Scotland Twp., Jul 16th, aged 87 years. Born in Argyleshire, Scotland, came with her husband and family to the U.S. in 1839 and to McDonough Co. in 1851....."

John (1832-1897) (Death Notice, in part, from The Macomb Times, Jul 14, 1897): "John McNair died at his home in Scotland Twp. aged 65 years, 6 months and 2 days....Deceased was born in Argyleshire, Scotland, and emigrated to this country, with his parents, in 1839. He has made his home in this county for years. His death was caused by a complication of diseases. He leaves four brothers and two sisters....."

(Camp Creek Cem)

MC NAIR: James L. (1829-1903) (Death notice, in part, from The Macomb Times, Feb 12, 1903): "James L. McNair died Feb 4, 1903, at his home in Scotland Twp. after an extended illness caused by general debility, aged 73 years, 4 months and 23 days...Deceased was born Sep 11, 1829, being a native of Argyleshire, Scotland. He came to America with his parents in 1839, locating in Ohio, where he remained until 1851, when he came with them to Illinois settling in Scotland township....."

MILLER: John (1779-1852) appears on the 1840 county tax list as #450; he owned 160 acres, the NW $\frac{1}{4}$ of section 7, Industry Twp.; also he had \$110.00 worth of horses, \$85.00 cattle, \$20.00 clocks and watches, \$30.00 wagons, and \$170.00 worth of other property; total taxes were \$6.03. NOTE: Notated beside Mr. Miller's name is the following: "A. C. Hardin, Monmouth, patent title to NW $\frac{1}{4}$ section 7, 4-2."

Lurner B.; native of Tennessee; moved to this county in the 1830's; wife was the former Amy Bridges; a son, John W., was born in Industry Twp. in 1837.

Wm. Benj. Miller married Mary Ann Lane in this county on Apr 14, 1846.

MILLS: Ladson (Death Notice, in part, from the Macomb Journal, Aug 13, 1885): "Ladison Mills died August 10th at his home in Bethel Twp. He was buried Tuesday in the Camp Creek burial ground. He was born on Feb 9, 1822 in Hendersonville, Rutherford Co., N. Carolina where he lived until he was grown and married in 1842 to Miss Sallie Hill. The came to Bethel Twp. in 1850. His son is Chas. Mills of Greeley, Kansas."

Ladison/Ladson (1822-1885) married Dec 8, 1843 to Sarah M. Hill, native of N.C.; had 11 children including: John A., Melissa, James E., Charles W., Anna, Mary, Seth, Sarah, Kate, Thomas, and Etta.

MONTGOMERY: Mary Jane; maiden name was Campbell; married Thos. P. Montgomery in this co. on May 17, 1843.

MOORE: Robert Keith; d. June 5, 1922; age 1y 5m 16d; son of Guy L. & Florence (Legere) Moore; death caused by being kicked by a mule at his home in Lamoine Twp.

MULLAN: (Also spelled Mullen/Mullens) Henry C. (1830-1894) born in Pa.; lived in Bardolph, Ill. before moving to section 32, Scotland Twp. in about 1860; enlisted in the army at Bardolph; commissioned 1st Lt on Oct 7, 1862; resigned on Jun 3, 1863.

MUNSON: Daniel (1815-1893); born in the state of Vermont; son of Theodore & Lydia (Filbrook) Munson; moved to Schuyler county, in 1831, with parents; Theodore died in that county in 1845; Lydia died here in 1866; Dan'l married in 1845 to Rosanna Costine; had 4 children: Charles, George, Anna, and Udora; the family moved to this county in 1851; lived on section 7, Industry Twp.

(Camp Creek Cem)

MUNSON: Daniel appears on the 1850 federal census for the city of Rushville; he owned \$1,500.00 worth of real estate and was a farmer; his wife, Rosanna, was born in Maryland in about 1826; Daniel's mother, Lydia, was living in that household at that time; she was born in N.H.

Charles (1846-1912), eldest son of Daniel and Rosanna (Costine) Munson; born in Schuyler co., IL; married in 1872, to Annie Kirkpatrick; had 2 children: George and Daniel R.

Eliphalet P. (1817-1907), brother to Daniel, appears on the 1850 Schuyler co., Ill. federal census; he was living in the town of Rushville and was a tailor by trade; he was born in the state of Vt.; he owned \$1,500.00 worth of real estate; his wife, Katherine was born in Maryland; children of E. P. and his wife on that list were as follows: (all born in Ill.) William T., age 11; Daniel P., 7; Mary F., 5; and Lydia A., 2. Also living in the Munson household at that time was John Winters, age 21, a native of Germany; he was also a tailor.

Lydia (1783-1866), wife of Theodore; born in Mass.; maiden name was Filbrook; married in about 1800; moved to Schuyler Co., Ill. in 1831; Mr. Munson died there in 1845; moved to this county in 1851; had 5 children.

NEAL: John married Susan Campbell in this county on Nov 9, 1849.

NISBET: Wm. married Jane Rice in this county on Sep 18, 1845.
(Name also spelled NESBITT)

NORTON: W. W., father of Willard, Sadie, and Carrie, operated a saw mill at Industry; he was born in Ohio and came to this county from Warren Co., Ill. in 1857.

NORVIL: Elizabeth A. (1837-1906) (Obit, in part, from The Macomb Daily By-Stander, May 17, 1906): "Mrs. John A. Norvil, resident of Macomb, died Thursday afternoon at her home, 121 West Washington street, from tuberculosis, aged 68 years, 6 months..... Elizabeth N. Henderson was born in Indiana Nov 21, 1837, and came to this county many years ago. Nov 21, 1861, she was united in marriage to John A. Norvil. To this union was born one child, Henry Norvil, who resides at Villisca, Ia. The deceased spent the greater part of her life in this county. She resided a short time in Nebraska, also a short time in the East. She lived a number of years in Scotland township and later in Bardolph, coming to Macomb a number of years ago.....She had been in poor health for a number of years....Besides her husband and the son mentioned above, she leaves two sisters, Mrs. Eliza McGaughey of Tina, Mo., and Mrs. Ellen Sanders of near Blandinsville, also one half-sister, Mrs. Mollie Mason of Tina, Mo."

PACE: William I. (1809-1855) appears on the 1840 county tax list as #440; he owned no real estate; had \$140.00 worth of horses, \$50.00 cattle, \$10.00 clocks and watches, \$60.00 wagons, \$10.00 cash loaned out, and \$180.00 in other property; taxes were \$2.25. Mr. Pace was the county assessor in 1840.

PACE: William I. was born in Ky.; married Sally S. Vawter and moved to this county in 1830; lived in Chalmers Twp.; moved to Scotland Twp. in 1835; had 8 children: Ingram A.; Thomas J.; Susan E. (Mrs. W. H. Dawson); George W.; Permelia J. (Mrs. George W. Porter); Andrew J.; Anna (Mrs. J. T. Adcock); and Amanda (Mrs. Henry Smith). Mrs. Pace died in 1851; William then married, in 1851, at Gettysburg, Pa., to Mrs. Esther Doubler; returned to Scotland Twp.; had a daughter, Fannie Bell (Mrs. Dewitt Roberts).

PARKS: John (1844-1918) enlisted in the army at Industry on Aug 19, 1862; served as a private with Co C (or A) 84th Ill Inf.; promoted to corporal and mustered out on Jun 8, 1865.

PEAK: Ellen G.; dau of John & Rachel (Taylor) Gibson; married to Wm. B. Peak; he died in 1904.

PEARCE: Nicholas H., father of Enoch & Emily, farmed on section 9, Scotland Twp.; he was born in Maryland and moved here in 1854, from Ohio.

PLASSMAN: August (1837-1914), born in Germany; moved to New Orleans, La. at age 18 years; then lived in St. Louis, and in Quincy, Ill. before moving to this county; married Oct 28, 1857, to Charlotte Rethorst, a native of Germany; farmed in Chalmers Twp.; had 9 children: Emma, Anna, Frederick, Maggie, Lou, Lillie, William, Charles and Henry. Carl August (1837-1914) was a son of Carl H. Plassman.

Mary (1838-1913), wife of August; daughter of Eben Rethorst, a native of Germany.

Frederick William (1867-1943), son of August & Mary Rethorst Plassman; born in Chalmers Twp.; fifth of a family of eight children; farmed on section 22, Chalmers; married Nov 22, 1892 to Annie Brall, a native of Macomb; had 4 children: Virginia, Otto August, Erma, and Charlotte.

PRICE: Sam'l, husband of Polly (1799-1873) appears on the 1840 county tax list as #450; he owned no real estate; had \$100.00 worth of horses; \$30.00 cattle, \$40.00 wagons, and \$75.00 in other property; taxes were \$1.23

PROVINE: Alexander (1806-1853) appears on the 1840 county tax list as #533; he owned 160 acres, the SE $\frac{1}{4}$ section 36, Bethel Twp.; he also had \$140.00 worth of horses, \$33.00 cattle, \$10.00 clocks and watches, \$35.00 carriages, \$60.00 wagons, and \$133.00 in other property; taxes were \$6.06. Alexander married 2nd on Dec 3, 1840 to Jane Harris in this county.

George W. (1813-1898) appears on the 1840 county tax list as #535; he owned no real estate; had \$120.00 worth of horses, \$39.00 cattle, \$10.00 clocks and watches, \$50.00 wagons, and \$279.00 in other property; taxes were \$2.82. George moved to this county in 1835; farmed in Scotland Twp.

(Camp Creek Cem)

PROVINE: George (1813-1898) (Obit, in part, from The Macomb By-Stander, Apr 13, 1898): "George J. Provine...resident of Scotland township, died at the residence of his son, W. S. Provineof pneumonia....He was nearly 85 years old....Mr. Provine was a native of Clark county, Ind., being born there May 5, 1813. He had spent most of his life in this county, having come here when quite young. He is survived by four sons: John A., of Canton; Hugh W., of Perry, Okla.; W. S. of Scotland Twp.; and J. H., of Macomb; also one brother, William Provine, of Vermont. Mrs. Provine whose maiden name was Mary McAlary, died over 20 years ago...." George married Mary McAlary or McNary in this county Nov. 24, 1836.

Robert A. (1843-1845) was a son of William and Paulina (Scott) Provine who were married in this county on Nov 22, 1838.

REYNOLDS: --- (Capt.); Granville H. Reynolds was commissioned Capt with Co I 78th Ill Inf. at Industry on Sep 1, 1862; he resigned from service on Dec 19, 1864.

RICE: William W. (1810-1850) appears on the 1840 county tax list as #457; he owned 120 acres in section 14 & 16, Industry Twp.; residence was in the SE $\frac{1}{4}$ of section 16; he owned \$120.00 worth of horses, \$50.00 cattle, \$65.00 wagons, and \$64.00 worth of other property; taxes were \$4.50.

RIGG: John E. (1814-1891), son of Sam'l & Nancy (Vawter) Rigg; born in N. Carolina; moved to this county in 1836; moved with parents to Kentucky; then to Sangamon Co., Ill. in about 1828; married in Morgan Co., Ill. to Ailsey Cox on Dec 31, 1835. Parents buried in Rigg family cemetery in Bethel Twp.

Ida M. (1863-1937); daughter of Mr. & Mrs. William Nunn; sister to Laura Nunn, who died in Oct, 1895; Mrs. B. Brooking; Mrs. Alice Miller; and Mrs. George Johnson.

SCOTT: Sarah (1791-1846), widow of Martin, appears on the 1840 county tax list as #390; she owned no real estate; had \$175.00 worth of horses, \$129.00 cattle, \$10.00 clocks and watches, \$75.00 wagons and \$500.00 in other property; taxes were \$4.45.

SCUDDER: On the 1860 federal census for Industry Twp., several members of 3 separate families were listed under a single household: they were Aaron & Jane Scudder (ages 32 & 31; both b. in Ohio); son, Leonidas, age 8, b. in Ohio; son, John, age 6, b. Ohio; daughter, Amelia, 5, b. Ill.; daughter Philitas, age 3, b. Ill.; and Benjamin, age 9 months, b. Ill. Martin and Isabel Scudder (ages 22 and 19; both b. in Ohio) and a son, James, age 9 months, were listed under the Aaron Scudder family. And, following the Martin Scudder family, is Enoch, age 62, and his wife, Amelia, age 63, both born in N.J.; last on this list is Mary Scudder, age 27, born in Ohio, and Ann, age 17, also b. in Ohio.

Martin V. (1837-1883) enlisted in the army at Industry on Aug 11, 1862; served as a private with Co I 78th Ill Inf; discharged due to a disability on Jun 30, 1863.

SCUDDER: M. V. (Death notice, in part, from the Macomb Journal, Dec 6, 1883): "Martin V. Scudder died Tuesday at Industry. He came to this area from Ohio in 1854 when he was 16 years old. He settled with his parents in the vicinity of Industry. In 1862 he enlisted with Company I 78th Ill Infantry. He was married twice, the last time to Miss Bridges and he leaves a number of children. He was a pensioner and was about 45 years old."

SEDERBURG: Lydia (1848-1917) (Obit, in part, from The Macomb Daily Journal, Mar 19, 1917): Lydia Ann Sederburg of 223 Bereford Ave. Detroit, Michigan, died Tuesday, March 13, 1917, at 5:45 a.m. She received an injury two years ago from which she never fully recovered. Her age was 68 years 11 months and 16 days..... Lydia Ann Munson was born in Rushville, Schuyler county, April 23, 1848 and moved to McDonough county in 1852 with her parents, Mr. & Mrs. E. P. Munson, deceased....Nov 24, 1868, she was united in marriage with Joseph Milton Butcher....They located on a farm in Industry township where they resided until 1873, moving to Winterset, Iowa, returning two years later to this county. In 1882, they moved to Tina, Mo., moving from there to Excelsior Springs, Mo., in 1888. In November of this same year they moved to Cameron, Iowa, where her husband died Tuesday, October 1, 1889. In 1896, she returned with her family to Tennessee, Ill. A few years later she moved to Monmouth, Ill., where she resided for several years. On Feb 14, 1911 she was united in marriage with Claf Sederburg of Monmouth....One year later she and her husband moved to Detroit where they resided until her death. She leaves to mourn her loss a husband and children: E.W. Butcher, Lucille, Idaho; Mrs. C. F. Schmoie, Shelbyville, Ind.; Mrs. Dean Osborn, Macomb; Mrs. L. A. Young, Detroit; Mrs. R.C. Schofield, Chicago; fourteen grandchildren; three sisters, Mrs. Ed James of Beardstown, Ill.; Mrs. Joe Clark, Conroe, Texas; Mrs. Harry Franklin, Houston, Texas.....The husband, four daughters and two grandchildren were at her bedside when the peaceful end came....."

SHEPHARD: Thomas J. (1845-1907) enlisted in the army in Bethel Twp. on Aug 2, 1862; later transferred from Co A 84th Ill Inf. to the Mississippi Marine Brigade on Apr 14, 1863.

SIMPSON: Josiah E. (1808-1887) born in Ky.; married Eliza Trotter, also a native of Ky.; Mr. Simpson was an early settler in this county, moved to this county in 1849 from Menard county, Ill., and was the first to raise high-grade cattle in this area; he farmed in section 2 Industry Twp.; J. E. and Eliza had 5 sons and a daughter, the youngest child being James Simpson, born in 1853. (Obit, in part, from The Macomb Journal, Mar 17, 1887): "Josiah Espey Simpson died Mar 12th, aged 79 years. He was born in Mt. Sterling, Ky. on Nov 2, 1808. He married Miss Eliza T. Rice of Adair Co., Ky. in 1835 and soon afterwards moved to Menard Co., Ky where they lived until the spring of 1850, when they moved to Industry Twp. His wife died Apr 30, 1862. They had 7 children—4 of whom survive: Joseph J. of Montgomery Co., Kansas; Clay of North Loup, Valley Co., Neb.; Wm. B. of Industry Twp. He was married second to Miss Maria Thompson of Littleton, Ill. on Mar 15, 1864. She survives....."

SIMPSON: Infant male; d. Sep 15, 1879; age 4d; b. & d. Industry.

SULLIVAN: Joseph (1787-1854), born in Va., Mar 2, 1787; son of Jeremiah Sullivan, a native of Va.; the family moved to Washington Co., Pa. in about 1802; Joseph moved to this county in 1835; lived in Industry Twp.; married in Pa. to Martha Lutton, a native of Md.

Joseph appears on the 1840 county tax list as #394; he owned no real estate; had \$80.00 worth of horses, \$40.00 cattle, \$10.00 clocks and watches, \$75.00 wagons, and \$100.00 in other property; taxes were \$1.15.

Listed directly below Joseph Sullivan, as numbers #395 and #396, are 2 Jeremiah Sullivan's; #395 is identified as "white head"; the first Jeremiah owned \$103.00 worth of personal property; the second had \$325.00 in personal property.

Jeremiah (1817-1871) born in Washington Co., Pa. on Feb 18, 1817; moved to this county in 1835; farmed in section 30, Scotland Twp.

Jeremiah married Margaret Foster in this county on May 4, 1843.

TAYLOR: Bentley (1861-1940); born in Chester Co., Pa. Feb 10, 1861; a son William and Hannah (Pyle) Taylor, natives of Pa.; Bentley moved to this county in the 1880's; he and a borther bought a farm in Emmet Twp.; later farmed in Scotland Twp.; married on Jun 1, 1887, to Alice J. Clark, a native of Scotland Twp.; children included Ralph, Anna, and Frank. Bentley Taylor was a brother of Charles W.

TEEL: Wilson; d. Dec 13, 1922; age 3y 3m; son of Mr. & Mrs. Sam'l Teel; d. at Bethel Twp.

TELFORD: Alexander, husband of Jane (1783-1846) appears on the 1840 county tax list as #456; he owned 240 acres in sections 10 & 15, Industry Twp.; residence was in the NW $\frac{1}{4}$ of section 10; he woned \$60.00 worth of horses, \$30.00 cattle, had \$50.00 cash loaned out, and had \$60.00 worth of other property; taxes were \$7.00.

J. F. Telford married Berilla/Barrilla Walker in this county on Oct 14, 1847.

TINSLEY: Telitha C. (1822-1847), wife of Nathaniel P. and daughter of Joseph Walker; married in this county on Sept. 20, 1838; had 4 children; a daughter, Mary C., married Albert Eads of Macomb. Mr. Tinsley was born in Va. in 1810; lived in Ky.; moved to Macomb in 1836; operated several businesses in Macomb; he died in 1882 in Macomb.

VAIL: Henry W. (1826-1894) (Obit, in part, from The Macomb By-stander, Apr 4, 1894): "Uncle Was Vail, of Industry, who was suffering from erysipelas, followed by gangrene, had his leg amputated below the knee last Thursday. Drs. Bolles, Creel, and Justice performed the operation. Mr. Vail rallied after the amputation and then grew worse and at 6 o'clock Tuesday morning passed away.....Deceased was born in Ohio in 1826. In 1867, he came to Illinois and located in Schuyler county. In

VAIL: Henry W. (Cont'd)

1867 he moved to Industry Township. In 1883, he moved to the village, where he continued to reside up to the time of his death. He was a prominent farmer and stock raiser, and was very energetic during his business life....."

Henry W. appears on the 1850 federal census for Schuyler Co., Ill. living in the same household as his mother, Parmelia, and a sister, Parmela; Henry's sister, Parmela, was born in Ohio in about 1824; the record indicates that both Henry and his wife, Rachel, were born in 1826 in Ohio; also listed as part of Henry's family was Esther Vail, age 20, also born in Ohio.

Henry's mother was born in N.J. in 1785 and died in 1852. Her will, dated Nov 18, 1846, was recorded at Butler Co., Ohio. It listed the following children: Fanny Luddington, Sarah Garrison, Elizabeth Vail (wife of Moses Vail), Rebecca Garrison, Amanda Garrison, Deziah Rogers, Pemelia Vail, Rhoda Jane Vail, Esther Vail, Daniel J., and Henry W. The will's executor was Sam'l Vail; witnesses were: Hampton Terrill and Vincent D. Enyart, Marion Co., Ind.

Henry W. was a son of Henry & Parmelia (Bridge) Vail; Henry was born in Butler Co., Ohio; Henry, Sr. died in about 1832; Mrs. Vail died in 1851; Henry, Jr., moved to Schuyler Co., Ill. in 1847; lived there about 20 years; then moved to Industry Twp. and owned a large farm in section 14 in Industry Twp.; later moved to the town of Industry. Married in Ohio on Sep 20, 1849, to Rachel Cox; had the following children: A. L., William T., George W., Orinda, James E., and May.
(Parmela, Parmelia and Pemelia—spelled all three ways in write-ups)

VENARD: George (1799-1867), born in Ky.; married Frances Mitchell; moved to this county in 1832; lived a short time in Morgan Co., Ill. where a son, Josephus B., was born in 1832. Had 9 children including J. B. and Robert H.

George appears on the 1840 county tax list as #539; he owned no real estate; had \$125.00 worth of horses, \$113.00 cattle, \$10.00 clocks and watches, \$20.00 wagons, and \$277.00 in other property; taxes were \$2.73.

Robert H. (1840-1900), son of George & Frances (Mitchell) Venard; born in Bethel Twp.; lived with parents till age 21; then spent a few years in Oregon & Calif.; returned here in 1866; married in 1868 to Orpha E. Weaver, a native of Pa.; had 4 children: Georgie F.; Wallace O.; Karl D., and Eliza E.

VAWTER: Wm. B. married Emma S. Venard in this county on Oct 22, 1844.

WALKER: Ethel (1896) (Death notice, in part, from The Macomb By-stander, Jul 1, 1896): "The infant child of Mr. & Mrs. Grier Walker died Monday morning at the home of its grandfather, William McMillen of Camp Creek. The cause of death was stomach trouble....."

WALKER: Alexander, father of several persons in this cemetery, was born in Va.; married there on Mar 22, 1790, to Mary Magdaline Hammond, a native of N.C.; Alex. and Mary had 11 children as follows: Joseph Gilmer (1793); Cyrus (1791); David (b. & d. 1795); Abner (1796); Cynthia (1798); Margaret (1800; md. John Calhoun); Allen (1802); Alecander (1803) Jane H. (1805); Andrew Hammond (1808); Pinkney (1811-1815); Mary Magdaline (Hammond) Walker died in 1811. Alexander then married Mrs. Margaret F. (1802-1858) born in Ky.; moved to this county in 1835 and settled on Camp Creek in Scotland Twp.; married Amelia Rice, a native of Ky.; on Jun 18, 1825; had 10 children: Lucilla (1826) Benjamin R. (1827); Mary A. (1829); Margaret P. (1831); Nancy J. (1834); Allen A., Jr. (1836); Sarah E. (1839); Amelia C. (1841); Theophilus G. (1843); Joseph A. (1846). Allen appears on the 1840 county tax list as #431; he owned 320 acres of land in Scotland Twp.; residence was on the NE $\frac{1}{4}$ of section 36; he also had \$190.00 worth of horses, \$175.00 cattle, \$40.00 wagons, and \$100.00 in other property; total taxes were \$10.53.

Amelia (1804-1866), wife of Allen, Sr.; born in Ky. in Dec., 1803; married in 1835.

Cyrus (1791-1875); born in Rockbridge Co., Va.; moved with parents as an infant to Adair Co., Ky.; moved to this county in 1833; lived in Macomb and was one of the first resident lawyers in this county; md. in Ky. to Flora Montgomery. Appears on the 1840 county tax list as #388; he owned property in various parts of the county; residence was indicated as being in the SW $\frac{1}{4}$ section of 23, Macomb Twp.; in the north half of the county Mr. Walker owned 810 acres of ground in Macomb and Mound Twps.; in the south half of the county, he owned 1,592 acres in Industry, Scotland, and New Salem Twps.; a total of over 2,400 acres of ground. His personal property consisted of \$350.00 worth of horses, \$45.00 worth of cattle, \$160.00 clocks and watches, \$300.00 carriages, \$75.00 wagons, he had \$1,930.00 cash loaned out; and had \$1,000.00 worth of other property.

Flora (1793-1862), wife of Cyrus, Sr.; born in Ky.; a daughter of Thomas & Polly Montgomery; md. in Ky.; a son, John Montgomery Walker, was born in Adair Co. in 1820.

Cyrus (1832-1909), son of Cyrus, Sr.; born in Adair Co., Ky., Sep 25, 1832; moved with parents to this county in 1833; raised in Scotland Twp.; married Sep 11, 1860, to Mary J. McGaughey; had a number of children including: John C., Flora H., Cynthia A., Arthur, Guy, Grier, Pitt M., and Nancy. Mary J. (1842-1922) was born in Putnamville, Ind.; wife of Cyrus, Jr.

Jane (1806-1844) appears on the 1840 county tax list as #543; her husband, John, is listed as #455; Jane owned no real estate; she had \$10.00 worth of cattle, \$200.00 cash loaned out, and \$24.00 in other property, personal; her taxes were \$1.17.

WALKER: James (1800-1886) (Death notice, in part, from The Macomb Journal, Feb 11, 1886): "James Walker, Sr. died at his home in Scotland Twp. last Thursday aged 75 years. He was born in Pa. and came to Doddsville, Schuyler county in 1835. After remaining there for a year or two, he moved to Scotland Twp. where he has lived since. He was married shortly after moving to McDonough Co. to Miss Nancy Allison. They had 5 children, all of whom are living and grown. They are: Smith, Robt., James A., Silas, and Mrs. A. J. Pace, living in the same township....." James and Nancy were married Dec 29, 1842.

John (1790-1870) appears on the 1840 county tax list as #455; he owned 160 acres, the SE $\frac{1}{4}$ section 9, Industry Twp.; he also had \$60.00 worth of horses, \$30.00 cattle, and \$168.00 in other property; taxes were \$5.29.

Margaret M. (d. 1863), wife of John M.; maiden name was Sample; married John Walker at West Point, Iowa on Jul 13, 1845.

Joseph M. (1794-1846) appears on the 1840 county tax list as #436; he owned no real estate; had \$130.00 worth of horses, \$95.00 cattle, \$50.00 clocks and watches, \$50.00 wagons, and \$500.00 in other property; taxes were \$4.38.

Margaret Josephine (1847-1922), wife of Joseph Walker; daughter of John & Mary (Mesbit) Marshall, both natives of Ohio; born in Cass Co., Ill., Jun 13, 1847; died Jan 2, 1922; resided in Industry Twp. Age when died 74y 11m 19d.

Mary Frances; d. Nov 10, 1879; age 25y 3m 4d; single; housekeeper; b. Industry Twp.; d. N. Johnson St., Macomb.

Robert A. (1848-1920) enlisted in the army at Macomb on May 20, 1864; served as a private with Co I 137th Ill Inf; mustered out on Sep 24, 1864.

WATSON: David (1793-1847) appears on the 1840 county tax list as #408; he owned 80 acres in the SE $\frac{1}{4}$ of section 28, Scotland Twp; he also had \$120.00 worth of horses, \$15.00 cattle, \$40.00 carriages, \$70.00 wagons, and \$165.00 in other property; taxes were \$3.65.

Albert B. (Nov 5, 1888-Oct 24, 1976); born in Scotland Twp. a son of John F. & Annie (Binnie) Watson; married Lena G. Henderson, on Dec 4, 1920; had 2 sons, Randall & Gene, and a daughter, Marilyn (Mrs. Chas. Cavett); he was a brother to Mary E. Watson, Mrs. Lily Barclay, and Mrs. Nellie Watson. His wife died on Feb 23, 1967; Mr. Watson died at the Americana Health Care Center, Macomb.

James G. (1823-1865) married Mary McMillan in this county on Sep 13, 1849.

WAYLAND: Joel married Isabella Champ in this county on Dec. 11, 1849.

WETHERHOLD: Julia; d. Jan 28, 1882; age 44y; married; d. at Macomb.

(Camp Creek Cem)

WETHERHOLD: A. P., father of Minnie (d. 1861), owned and operated a general merchandise store in Macomb for a number of years beginning in the 1850's.

Notes, Corrections, Additions, and Changes

Remarks: The fence is chiefly fenced. Broken fence between Wetherhold and Richardson, during the winter after the death of the latter. Another son, James A. Wetherhold, died of cholera in 1853. Cynthia D. wife of Wetherhold, died in 1853. Mary J. Sims, wife of Wetherhold, died in 1853.

ROBERTSON: Mrs. W. Robertson, New Salem, Mo. died in 1853. Her husband was a blacksmith.

He had a son, S. P., who later lived in Macomb. Elizabeth was born in 1797 and died in 1871. (Note on - executor court)

(section 1); his residence was on the SW $\frac{1}{2}$ of section 34, New Salem Twp.; he also owned \$275.00 worth of horses, \$245.00 cattle, \$10.00 clocks and watches, \$75.00 wagons, and \$473.00 in other property; his total taxes were \$14.00.

(Death notice, in part, from The Macomb Journal, Thurs. Jan 28, 1886): "Richard Craig, an old settler of McDonough County, died at his home in Industry on Monday aged about 90 years. He had lived in this county for 40 years or more."
